I. STATUS

- A. <u>Ecosystem-Based Fishery Management Strategy Review Report:</u> Dr. Lisa Kerr, will summarize the final findings and recommendations of the CIE review.
- B. Example Fishery Ecosystem Plan (eFEP): The EBFM Committee met on June 21, 2018 to discuss the next steps for developing an eFEP. A more detailed outline and timeline (see Document 5) for development was presented to the committee by staff. The committee agreed to the timeline for further development work by the PDT. The PDT was unable to meet during August and September, but during an August 3rd conference call, members agreed to develop a discussion paper on the items highlighted in red in Document 5. A PDT meeting has been scheduled for October 10, to be followed by a Committee meeting in November.
- C. Northeast Regional Implementation Plan (IP) of NOAA Fisheries Ecosystem-Based Fisheries Management Roadmap: The EBFM committee heard a presentation by GARFO on the proposed IP and developed comments for Council approval.
- D. <u>State of the Ecosystem Reports:</u> Staff participated in a two-day planning meeting hosted by NEFSC to provide feedback on and improve the utility of these annual reports to Councils.
