# I. STATUS

- A. Meetings: The Groundfish Committee and Groundfish Advisory Panel jointly met on Oct. 30, and Nov. 25, 2019 to discuss Framework Adjustment 59, Amendment 23, and possible priorities for 2020. The Recreational Advisory Panel met on Nov. 12, 2019 to discuss Framework Adjustment 59, recreational data and issues, and possible priorities for 2020. The Groundfish Plan Development Team met on Sep. 30, Oct. 9, Oct. 21, and Nov. 5, 2019.
- B. <u>Framework Adjustment 59 (Specifications/Management Measures):</u> This action is scheduled for final action and includes (1) 2020 TACs for U.S./Canada stocks; (2) 2020-2022 specifications for 15 Northeast multispecies stocks, (3) addressing commercial/recreational allocation if raised by MRIP data; and (4) removing allocation to Closed Area I Haddock Special Access Program.
- C. <u>Amendment 23/Groundfish Monitoring:</u> Staff will provide an update on the development of the Draft Environmental Impact Statement (DEIS) to the Council.
- D. <u>Public Listening Sessions on the Possibility of Limited Entry in the Groundfish Party and Charter Fishery:</u> The Council will receive and discuss the final report summarizing the listening sessions and public comments.
- E. <u>Greater Atlantic Regional Fisheries Office's Recreational Workshops:</u> The Council will receive an overview of the recent regional workshops in October 2019 that built off the outcomes of a 2017 workshop.
