Groundfish Committee

I. STATUS

- A. <u>Meetings:</u> The Groundfish Committee met on Sept. 18, 2018 to discuss two management actions, Framework Adjustment 58 and Amendment 23, and an initial list of 2019 priorities. At the meeting, the Committee reviewed the work of the Groundfish Plan Development Team (PDT) and recommendations from the Advisors on the draft management actions and developed recommendations for the Council to consider. The Groundfish Advisory Panel met on Sept. 18, 2018 in the morning before the Committee convened in the afternoon. The Groundfish PDT met on July 31, Aug. 7, and Aug. 22, 2018. The Fishery Data for Stock Assessment Working Group met on June 25, Aug. 6, and Sept. 7, 2018.
- B. <u>Transboundary Resource Assessment Committee (TRAC) /Transboundary Management Guidance Committee (TMGC)</u>: The TRAC met July 10-12, 2018 in Woods Hole, MA to conduct assessments for Eastern Georges Bank (GB) cod, Eastern GB haddock, and GB yellowtail flounder. The TMGC met on Sept. 11-12, 2018 and the Steering Committee met on Sept. 12-13, 2018 in Boston, MA to discuss quotas for US/Canada stocks and other management issues. The Council will receive an overview of the assessments from the U.S. TRAC chair and an overview of the discussion and recommendations on quotas for fishing year 2019 from the U.S. TMGC chair.
- C. <u>Framework Adjustment 58 (specifications/management measures)</u>: This action was initiated at the June Council meeting. It would revise/establish rebuilding plans for several stocks (ocean pout, GB winter flounder, witch flounder, Gulf of Maine (GOM)/GB Northern windowpane flounder, and Southern New England/Mid-Atlantic yellowtail flounder), set specifications for FY2019 for US/Canada stocks, exempt vessels fishing in Northwest Atlantic Fisheries Organization (NAFO) waters from the Northeast Multispecies Fishery Management Plan (FMP) commercial minimum fish sizes, and provide additional guidance on sector overages.
- D. <u>Amendment 23/Groundfish Monitoring:</u> Staff will provide a progress update on development of the range of alternatives to the Council and an update from the Fishery Data for Stock Assessment Working Group.
