### **Ecosystems Based Fishery Management Committee**

## I. STATUS

- A. <u>Meetings:</u> The EBFM Committee met via a remote session on July 21 and September 8, 2020. At both meetings, the committee reviewed and provided guidance on draft outreach materials developed by <u>GreenFinStudio</u> (GFS) and on the PDT's development of tangible worked example demonstration tools. The PDT met twice by webinar on July 14 and August 26 to develop the Tangible Worked Example demonstration tools.
- <u>EBFM Public Outreach</u>: The Council chose GFS as a science communicator to develop public outreach materials that the Council specified in a statement of work based directly on the advice of the <u>December 2019 MSE Steering Committee report</u>. Working with <u>Eating with the Ecosystem</u> as a subcontractor, GFS has developed stakeholder profiles, two infographic fact sheets, and three workshop presentations, three stakeholder brochures, a glossary brochure, a Guide to the example Fishery Ecosystem Plan brochure, and is developing a 5-minute introductory video and a fourth presentation.

In response to the EBFM Committee's guidance and request, the PDT developed three Tangible Worked Example demonstration tools. Two are interactive programs, one is a four stock/two stock complex model that demonstrates the proposed ceilings and floors approach to manage catches of stock complexes and another four stock complex model that demonstrates the effect that biological and technical interactions have on stock complex biomass. A third product is a simplified document that describes the Hydra operating model with four scenarios to demonstrate how it can be used to evaluate tradeoffs between management objectives.
