Re: Atlantic Herring Fishery Specifications for FY 2013-2015

Dear Chairman Cunningham,

As a member-based non-profit organization representing 120 independent fishing businesses and 300 fishing families on Cape Cod, we understand the importance of a robust forage base as the first step to a healthy and balanced ocean. We have been closely monitoring the development of the FY2013-2015 Atlantic Herring specifications package and we would like to bring the New England Fishery Management Council's (Council) attention to several matters.

Compliance with annual catch limits (ACL) and accountability measures (AM) are required in provisions set forth by law, and are essential to the long-term sustainability of the herring stock and the ecosystem as a whole. The herring fishery has exceeded sub-ACLs in various management areas too often in recent years and this past year has also exceeded its overall ACL. A well-crafted specifications package must establish a sustainable ACL and sub-ACLs as well as meaningful AMs designed to allow the fishery to fully harvest the quota without incurring damaging overages.

For these reasons, we support the following measures:

- **Hybrid Sub-ACL Allocation Option Proposed by the Herring Advisory Panel**

This option allocates 31,200 metric tons (mt) to Area 1A, 4,600mt to Area 1B, 30,000mt to Area 2, and 42,000mt to Area 3. We support this option because it promotes the offshore herring fishery, thereby providing benefits to the industry while protecting the inshore component of the herring stock.

- **AM Alternative 2 with an Accompanying Underage Rollover Provision**

We support the proposal to lower the trigger for closing the directed herring fishery in a management area to 92% of the sub-ACL in tandem with a provision that allows the fishery to rollover a maximum of 10% of any unharvested quota, so long as it does not exceed the overall ACL. A rollover provision should diminish the perceived risk of leaving fish in the water and encourage fishery managers and industry members to achieve optimum yield without accruing overages.
