




Background

- The <u>strategic plan will directly focus on near- and long-term Council initiatives</u> that can support resilient and responsive fisheries management.







Goals of Strategic Plan Development

- Considering improvements in the process of developing federal fisheries management actions from early considerations to rulemaking;
- Identifying existing and emerging topics and processes that require increased responsiveness, and document the risks and challenges that Councilmanaged fisheries face within and across FMPs and jurisdictions; and
- Establishing mission and vision statements along with strategic goals that will guide Council activities and actions in the <u>near and long-term</u> in the face of uncertainty and ecosystem changes.
