EO 14008: Tackling the Climate Crisis at Home and Abroad

- President Biden's Executive Order, dated January 27, 2021.
- Section 216(c) directs NOAA to collect recommendations on how to make fisheries, including aquaculture, and protected resources more resilient to climate change, including changes in management and conservation measures, and improvements in science, monitoring, and cooperative research.
- NOAA's 30-day comment period ended April 2, 2021, and Council listening sessions were held.
 We anticipate this effort to be part of a long-term process for responding to the pervasive impacts of climate change on marine resources and the communities that depend upon them.
- Input will inform the next series of Regional Action Plans under the NOAA Fisheries Climate Science Strategy.
- NMFS Leadership will speak to this issue further on Thursday.

Litigation: PLL Bluefin Tuna Area-Based and Weak Hook Management Measures

- Lawsuit filed by EarthJustice, on behalf of Healthy Gulf and Turtle Island Network
- Filed on April 29, 2020
- Administrative record filed June 18, 2020
- Supplement to the record filed August 25, 2020
- Briefing completed in December 2020
- Awaiting judge's ruling



2021 Appropriations Act Joint Explanatory Statement (JES)

Spring Gulf of Mexico Monitoring Area

- Language in the JES directed NOAA Fisheries to reconsider the GRA-WH Rule decision to open the Spring Gulf of Mexico Monitoring Area or to increase monitoring in the area.
- NOAA Fisheries will publish a public request for any information not considered in development of the final rule
- NOAA Fisheries will accept comments for 30 days and will review the comments submitted and consider whether additional action is necessary.
- We are seeking any information not considered in the final rule from the AP at this meeting.
- Bluefin tuna catch data is posted on the GRA/WH <u>rulemaking page</u>



2021 Appropriations Act Joint Explanatory Statement

- Shark and Marine Mammal Interactions (Depredation)

- Congress has directed the Agency to undertake a review "...to assess and better understand the occurrence of conflicts between dolphins and sharks and commercial, for-hire, and recreational fishing vessels in the Gulf of Mexico and South Atlantic."
- NOAA Fisheries is working on such a review.
- We expect to share a draft of the review with the Gulf of Mexico and South Atlantic Fishery Management Councils and the HMS AP in the Fall.
- Note: SHARE (to be discussed later at this meeting) also considers shark depredation.



Shark Updates

- Amendment 5b dusky sharks
 - Oceana first challenged Amendment 5b in this case in May 2017
 - On March 30, 2021, the District Court (for D.C.) fully upheld Amendment 5b
- Shark Fin Bills continue to be considered by Congress and states
 - S. 1106/H.R. 2811 and S. 1372
 - FL bill effective January 2021; exemption for federal shark dealers/fishermen/exporters who held a permit as of January 2020
 - NJ bill effective January 2021
- Assessments: Atlantic blacktip (SEDAR) and Porbeagle (ICCAT) complete, results preliminary; Hammerhead research track underway
- Amendment 14 (ABC Control Rule): Reviewing comments; drafting final documents

2020 Landings of Blue and White Marlin and Roundscale Spearfish – Update since the December 2020 AP Meeting

- NMFS monitors landings throughout the fishing year to ensure that the U.S. recreational fishery remains within the ICCAT-established limit of 250 landings for all these species combined
- Unique 2020 QA/QC issue integration of eTrips data and tournament landing trend
 - Released fish incorrectly reported via eTrips as landings (corrected)
 - High levels of tournament landings in summer 2020
- Final 2020 landings estimate (asof April 2021) = 235 billfish
 - 74 blue marlin, 95 white marlin, 66 roundscale spearfish
 - No minimum size limit warranted for 2021
 - Will monitor 2021 landings closely and adjust if necessary



Paperwork Reduction Act

- We are seeking public comment on PRA renewals for multiple HMS data collections under the following OMB Control Numbers:
 - 0648-0040 HMS Dealer and Bluefin Tuna Trade Reporting
 - 0648-0677 Individual Bluefin Tuna Quota Reporting
 - 0648-0372 MS Electronic Monitoring and Vessel Monitoring Systems
 - 0648-0327 HMS Permit Family of Forms
- Specifically, we are interested in comments on:
 - the utility of the data collected
 - the accuracy of our burden (time and cost) estimates
 - ways to enhance the quality of the data collected
 - ways to minimize reporting burden

Some other things might impact HMS fisheries

- Pelagic Longline Take Reduction Plan Changes: Proposed rule published 12/15/2020
- <u>Atlantic Large Whale Take Reduction Plan Possible Changes:</u> Modifying model to look at gillnet gear; various public meetings happened in April; expect more meetings in future
- Expansion of Flower Gardens Banks National Marine Sanctuary
 - Final Rule published January 19, 2021 (86 FR 4937).
 - Adds ~104 sq mi, protects 14 additional reefs and banks in the Gulf of Mexico.

Some other things might impact HMS fisheries

- Gulf of Mexico Coral Amendment 9: final rule published 10/16/2020
- Expansion of Florida Keys National Marine Sanctuary: DEIS and Restoration Blueprint released 8/20/19 and comment period ended 1/31/2020
- <u>Aquaculture</u>: HMS Management Division is participating in a Southeast IPT for Aquaculture;
 Agency actively involved in multiple consultations and in site analyses
- Modification of Fishing Access in Eastern Gulf of Mexico MPAs (Madison-Swanson / Steamboat Lumps): request for commensurate regulations for Atlantic HMS from the Gulf Council
- NE Canyons and Seamounts: Pursuant to E.O. 13990, Sec. of Interior must review the June 5, 2020 Presidential Proclamation that lifted the prohibition on commercial fishing in the Canyons and Seamounts Marine National Monuments

Southeast For-Hire Electronic Logbook Reporting

South Atlantic final rule published February 24, 2020

 Effective January 4, 2021 for Atlantic Dolphin/Wahoo; South Atlantic Pelagic Fish and Snapper/Grouper permit holders.

Gulf of Mexico and VMS type-approval final rules published July 2020

Effective January 4, 2021 for Gulf of Mexico CHB Pelagic Fish and Reef Fish permits. VMS implementation date is TBD.

HMS Division continues to work with ACCSP and GARFO to incorporate HMS Catch Reporting data elements to eTRIPS and eVTR to eliminate need for duplicate reporting; work is being done through One Stop Reporting initiative.

Electronic Vessel Reporting

The HMS Management Division is involved with the One Stop Reporting (OSR) initiative to streamline and create electronic vessel reporting.


- The OSR team is working on ways to create streamlined electronic reporting for vessels that have multiple permits
- This involves creating electronic reporting programs that can accommodate reporting requirements for multiple fisheries in different regions
- Driven by GARFO's need to have a simplified electronic vessel reporting system by the Summer of 2021
- Currently, the eTrips program fulfills reporting requirements associated with GARFO,
 HMS handgear, and SEFHEIR fishing permits; in the near future the Southeast Coastal Fisheries and HMS Logbooks requirements will also be included in eTrips



Offshore Wind

Many projects moving forward under "One Federal Decision" with BOEM

- HMS Division is coordinating with GARFO, SERO, and Science Centers on project reviews, impact assessments
