Agenda:

The PDT will review preliminary survey results from all 2016 scallop surveys available, including: the ME DMR survey of the Northern Gulf of Maine, SMAST video surveys, Arnie's and WHOI Habcam surveys, VIMS dredge survey and the federal NEFSC scallop survey. Based on these results and preliminary fishery data from FY2016 the PDT will begin discussing possible alternatives for FY2017 fishery allocations. The PDT will also continue the development of management measures in scallop Framework Adjustment 28, and review relevant analyses. Finally, the PDT will make recommendations for the Scallop Committee to consider for 2017 work priorities related to the Scallop FMP. The PDT may discuss other issues not listed on this agenda.

Directions:

From Boston / Points North: Take Route 1-93 South to Route 3 South to the Sagamore Bridge Rotary. Just before the Sagamore Bridge, take Route 6 West following the signs to Buzzards Bay / Falmouth, then cross over the Bourne Bridge and follow directions from the Bourne Bridge (below).

From the Bourne Bridge: Follow Route 28 south for approximately 10 miles to the first set of traffic lights and turn left onto Jones Road. At the next set of lights, take a left onto Gifford Street. The Coonamessett Inn is on the right.

The New England Fishery Management Council generally posts announcements of Plan Develop Team (PDT) meetings on the Council's website, occasionally with very little notice. An agenda may or may not be included. Team members may discuss topics, if listed, in any order or add other issues not contained in the meeting notice.

Members of the public may attend PDT meetings, or listen in if the meetings are broadcast but should not expect to participate unless the PDT chair invites input. Public comments and question will not be taken during PDT conference calls

PDTs are responsible to the Council and work on technical analyses as directed by their oversight committees. Once complete, PDT work products are reviewed at oversight committee meetings to which the public is invited. It is at this point that comments are encouraged on a range of issues, including PDT reports and recommendations, proposed management options or other information that is relevant to the committee's business at that time. The committee, in turn, makes management recommendations to the full Council based on the full suite of information it has available to it.
