### **Directions:**

<u>From the South:</u> Take I-95 North to Exit 3, make a right onto Route 33 East. Drive approximately 1 mile and make a right at the traffic light onto Peverly Hill Road. Go straight (across Route 1) and street name changes to Elwyn Road. Take third turn onto Sagamore Avenue, left onto Wentworth Road and destination is on right.

<u>From the North:</u> Take I-95 South to Exit 5, toward Newington/Dover. Merge onto US-4 E/NH-16/Spaulding Turnpike toward US-1 Bypass/Portsmouth Circle. Enter next roundabout and take the 2nd exit onto US Highway 1 Bypass/US-1 Bypass South. Turn left onto Lafayette Road. Turn right onto South Street. Turn right onto Sagamore Ave/NH-1A. Turn left onto Wentworth Rd/NH-1B. The hotel will be on the left.
