**Directions:**

From I-95 North or South - take Exit 7A (Mansfield Route 140). At the second set of lights, take a right onto Forbes Boulevard. Continue straight on this road and it will change to Cabot Boulevard. The hotel is at the end of Cabot Boulevard.
