The Scientific and Statistical Committee will meet to:

- Review recent stock assessment information from the 2019 Groundfish Management Track Assessments, information provided by the Council's Groundfish Plan Development Team (PDT) and recommend the overfishing limits and acceptable biological catch for Georges Bank (GB) cod, Gulf of Maine (GOM) cod, GB haddock, GOM haddock, Cape Cod/GOM yellowtail flounder, Southern New England/Mid-Atlantic yellowtail flounder, GB winter flounder, American plaice, witch flounder, pollock, white hake, Atlantic halibut, Northern windowpane flounder, and Southern windowpane flounder for fishing years 2020-2022.
- Review the information provided by the Council's Scallop PDT and recommend the overfishing limits (OFLs) and acceptable biological catches (ABCs) for Atlantic sea scallops for fishing years 2020 2021 (default).
- Discuss other business as necessary.

## **Directions:**
