**SUBJECT:** Groundfish Committee meeting on Sept.12, 2016

There will be a Groundfish Committee meeting at the Fairfield Inn and Suites, New Bedford, MA on Monday, Sept. 12, starting at 10:00 a.m.

**Purpose.** The purpose of the Committee meeting is to discuss 1) development of Framework Adjustment 56 (FW 56) – specifications and management measures, 2) the groundfish monitoring action, 3) possible priorities for 2017 and initial recommendations to the Council, and 4) other business, as necessary.

# Framework Adjustment 56

**Recent Activity:** The TRAC met on July 12-14 to discuss the assessments of US/Canada stocks - Eastern Georges Bank cod, Eastern Georges Bank haddock, and Georges Bank (GB) yellowtail flounder. The PDT met on Aug. 16, Aug. 31, and Sept. 6 and developed analysis for FW 56 (Docs. 3a-3d, 3e4). The SSC met on Aug. 10, 2016 and made recommendations regarding the FY 2017-FY 2018 ABCs/OFLs for Georges Bank yellowtail flounder (3e5). The RAP met on Aug. 2, 2016 and provided recommendations (5a). The GAP met on Aug. 30, 2016 and provided recommendations and market and fishery information (Doc. 5a, 3f1-3f2). The TMGC/SC will meet on Sept. 7-9 to discuss quota recommendations for US/CA stocks (Doc. 3h).

**Next Steps**: On Sept. 12, Council staff will present an overview of work on Atlantic halibut and a draft letter regarding the halibut issue for consideration by the Committee (3i), then an

update on progress on the action (3g) followed by a draft report from the TMGC (3h). After reviewing the information provided, the Committee may wish to develop recommendations regarding FW 56 to the Council.

The Council is scheduled to approve the range of alternatives for FW 56 at its September 2016 meeting.

# **Groundfish Monitoring Action**

**Recent activity.** The PDT met on Aug. 16 and 31. Since the June 2016 Committee meeting, the PDT completed a draft outline for the white paper on monitoring strategies (Doc. 4a) and a draft report on dockside monitoring programs (Doc. 4b) to be included in the white paper, and provided a report on progress (Doc. 4c). Additional analyses for the white paper are in progress at this time. The GAP met on Aug. 30 and discussed perspectives on the 2010-2011 dockside monitoring program (5b).

**Next Steps.** On Sept. 12, Council staff will provide an overview of progress on the white paper. The Committee will potentially develop recommendations regarding the action to the Council.

The Council is scheduled to receive an update on the development of this action at its September 2016 meeting.

### **Council Priorities for 2017**

**Recent Activity.** The Advisors discussed recommendations to the Groundfish Committee for 2017 Council priorities (Docs. 5a and 5b).

**Next Steps**. On Sept. 12, the Committee will have an initial discussion of priorities and make recommendations to the Council.

The Council is scheduled to have an initial discussion of priorities at its September 2016 meeting, with the final discussion occurring at its November 2016 meeting.
