There will be a **Groundfish Committee** meeting at the **DoubleTree by Hilton, Danvers, MA** on **Tuesday, January 15**, starting at **10:00** am.

<u>Purpose</u>. The purpose of the Committee meeting is to discuss and make recommendations to the Council on: (1) the draft alternatives for Amendment 23/Groundfish Monitoring, (2) a proposal for a new groundfish sector, (3) the draft outline for the Groundfish Catch Share Review report, (4) 2019 research priorities, and (5) other business as necessary.

Due to the partial federal government shutdown, NOAA staff are on furlough and unable to complete the work for recreational management measures in time for the Recreational Advisory Panel (RAP) and Groundfish Committee meetings. Therefore, we postponed recreational discussions and will work to reschedule meetings quickly once the shutdown ends. Although the RAP meeting is canceled for January 15, the Groundfish Committee meeting will still take place, starting at the revised time of 10am.
