SUBJECT: Skate AP and Committee Meetings on May 21 & 22, 2019

There will be a Skate AP and Committee meeting at the Hilton Providence in Providence, RI on Tuesday, May 21, 2019 and Wednesday, May 22, 2019. Both meetings start at 9am.

<u>Purpose</u>: The Committee raised questions about objectives for limited access in the skate fishery at its April 25, 2019 meeting. The Committee wanted clear objectives to be identified that would justify the need for limited access and, if justified, structure a limited access program that reflects two distinct fisheries as well as their directed and incidental components. The PDT compiled potential objectives from scoping comments for consideration and completed requested analyses on trip frequencies and number of vessels qualifying for permit categories proposed by the AP. The primary task for the AP and Committee is to develop draft objectives for limited access in the skate fishery to continue development of this action.
