SUBJECT: Purpose and agenda for meeting

The Ecosystem Based Fishery Management (EBFM) Plan Development Team (PDT) will meet by webinar from 1:00 to 5:00 pm on April 25, 2023.

<u>Purpose</u>: This meeting will review the initial runs and sample output from a Prototype Management Strategy Evaluation (pMSE) for Georges Bank Ecosystem-Based Fisheries Management (EBFM). The pMSE is based on the ceilings and floors catch management approach outlined in the example Fishery Ecosystem Plan (eFEP). The meeting will also seek technical guidance and feedback from the PDT, which will be incorporated into the final results expected in June. Specifically, the PDT's guidance is expected on the output of simulations that evaluate management procedures under a variety of scenarios from the Hydra operating model, as well as examples of summaries that convey the relative performance of management measures.

The Council is conducting the pMSE to develop the necessary tools for potentially conducting a full stakeholder-engaged MSE in 2024 and to understand the gaps in information and analyses that will be needed. Dr. Gavin Fay and Dr. Lisa Kerr are leading and conducting the pMSE. The PDT, stakeholders, and the Scientific and Statistical Committee have provided input on the objectives, performance metrics, operating models, and management procedures that will be used in a closed-loop simulation.

Summaries of pMSE stakeholder meetings are available on the Council's EBFM page. A draft summary of the March 16 stakeholder workshop will be distributed with the package of PDT meeting materials. In addition, the Council will be conducting deep-dive workshops to engage with stakeholders about eFEP and potential EBFM strategies, using the communication tools that were developed by the PDT and refined by Greenfin Studio. Two one-day webinars and one plenary of up to two days are being planned for late summer/early fall.
