- Alternative 2 ABC: 32,715 mt


#### Skate possession limits

- Wing
  - No Action: 2,600 lb/4,100 lb
  - Alternative 2: 3,000 lb/5,000 lb
- Bait
  - No Action: 25,000 lb/25,000 lb/12,000 lb
  - ▶ Alternative 2: 25,000 lb in all 3 seasons

  - Catch/biomass medians






#### Survey Indices




