# Providing and Enhancing Recreational Fisheries Opportunities (6/03/1996)

The Fish and Wildlife Service and the National Marine Fisheries Service (Services) have adopted a policy that will address the conservation needs of species listed, or proposed to be listed, under the Endangered Species Act of 1973, as amended (ESA) while providing for the continuation and enhancement of recreational fisheries. This policy identifies measures the Services will take to ensure consistency in the administration of the ESA between and within the two agencies, promote collaboration with other Federal, State, and Tribal fisheries managers, and improve and increase efforts to inform nonfederal entities of the requirements of the ESA while enhancing recreational fisheries. This policy meets the requirements set forth in Section 4 of Executive Order 12962. Recreational Fisheries.

The Strategy for Sea Turtle Conservation and Recovery in Relation to Atlantic and Gulf of Mexico Fisheries (Strategy) is a component of the larger NOAA's National Marine Fisheries Service's North Atlantic and Gulf of Mexico sea turtle conservation program. The primary emphasis of the Strategy is to reduce sea turtle bycatch in North Atlantic and Gulf of Mexico state and federal fisheries.

NOAA issues a policy for NMFS, which provides a focus for NMFS' habitat conservation activities, while at the same time integrating habitat conservation considerations through major programs and activities of the agency. This policy also encourages greater participation by the Regional Fishery Management Councils, the states and others in habitat conservation matters. This action is necessary in order to focus its habitat conservation activities on those species for which NMFS is primarily responsible or which are the subject of a NMFS program.

# 03-201 Essential Fish Habitat (12/27/2005)

It is the policy of NOAA Fisheries Office of Habitat Conservation to ensure the conservation and enhancement of essential fish habitat (EFH) in accordance with the Magnuson-Stevens Fishery Conservation and Management Act (16 U.S.C. 1801 et seq.) and other relevant authorities and guidance promulgated by Congress, NOAA and other Federal agencies.

This memorandum clarifies NMFS' responsibilities under the Magnuson-Stevens Fishery Conservation and Management Act and Essential Fish Habitat regulations to assess the impacts of fishery management actions on EFH and to conduct EFH consultations, if required. NMFS must analyze impacts of EFH and comply with the EFH consultation requirements for every fishery management action taken under authority of the Magnuson-Stevens Act for which a final decision has yet to be made.

### **Consultations (1/01/2001)**

The 1996 amendments to the Magnuson-Stevens Fishery Conservation and Management Act (MSA)(16 U.S.C. 1801 et seq.) require the identification of Essential Fish Habitat (EFH) for Federally managed fishery species and the implementation of measures to conserve and enhance this habitat. The MSA requires Federal agencies to consult with the National Marine Fisheries Service (NMFS) on activities that may adversely affect EFH (MSA section 305(b)(2))1. There are many situations where designated EFH overlaps with the habitat (including critical habitat) of species listed as threatened or endangered under the Endangered Species Act (ESA). Thus, a proposed Federal action could affect both a listed species and its designated critical habitat and adversely affect EFH, necessitating consultation under both section 7 of the ESA and section 305(b)(2) of the MSA. Because of this dual obligation, the Federal action agency and NMFS can find efficiencies by integrating EFH and ESA consultations.

Once NMFS has reviewed the EFH Assessment and analyzed possible adverse effects to EFH resulting from the proposed action, NMFS must develop EFH Conservation Recommendations (MSA section 305(b)(4)(A)). These recommendations may include measures to avoid, minimize, mitigate, or otherwise offset adverse effects on EFH. EFH Conservation Recommendations will not include actions beyond the statutory authority of the Federal action agency (50 CFR 600.925(a)). Fishery Management Councils (Councils) may also comment on actions that may adversely affect EFH (MSA section 305(b)(3)). Thus, it may be necessary for NMFS to coordinate with the Council(s) regarding NMFS' EFH Conservation Recommendations.

### Particular Concern (5/01/2001)\*

The 1996 Amendments to the Magnuson-Stevens Fishery Conservation and Management Act focused increased attention on the importance of habitat protection to achieving sustainable fisheries. Congress stated in the Act, "one of the greatest long-term threats to the viability of commercial and recreational fisheries is the continuing loss of marine, estuarine, and other aquatic habitats" (16 U.S.C. 1801). Based on this finding, Congress required Councils to describe and identify essential fish habitat (EFH), defined as those waters and substrate necessary to fish for spawning, breeding, feeding or growth to maturity, and mandated that regional Fishery Management Councils (Councils) minimize to the extent practicable the adverse effects of fishing on EFH and identify other actions to conserve and enhance EFH.

The National Marine Fisheries Service (NMFS) developed regulations (50 CFR 600 Subpart J; 62 FR 665531) to guide Councils in the implementation of the EFH provisions. The EFH regulations encourage Councils to identify Habitat Areas of Particular Concern (HAPCs) within areas designated as EFH to focus conservation priorities on specific habitat areas that play a particularly important role in the life cycles of federally managed fish species.

This report identifies the areas designated as HAPCs in each region, analyzes different Council approaches to HAPC designations, summarizes Councils "progress with respect to HAPCs subsequent to the initial designations, and offers recommendations for future HAPC designations. The <u>purpose</u> of this report is to share information and allow each Council (and interested stakeholders) to benefit from others" experiences with HAPCs.

The Department of Commerce's guidelines for implementing the EFH coordination and consultation provisions of the MSA are at 50 CFR 600.905 - 930. These guidelines provide definitions and procedures for satisfying the EFH consultation requirements, that include the use of existing environmental review processes, General Concurrences, programmatic consultations or individual EFH consultations (i.e., abbreviated, expanded) when an existing process is not available. The EFH guidelines also address coordination with the Fishery Management Councils (Councils), NOAA Fisheries EFH Conservation Recommendations to Federal and state agencies, and Council comments and recommendations to Federal and state agencies.

<u>Purpose</u>: This document was developed to provide additional guidance on the procedures that have been developed to assist NOAA Fisheries and other Federal agencies in addressing the EFH coordination and consultation requirements established by MSA and the EFH consultation guidelines. This document also establishes a consistent, efficient approach to conducting consultations.

The description and identification of essential fish habitat (EFH) establishes the nature and geographic extent of habitat necessary for managed fish so that management actions can be taken to conserve such habitat thereby supporting sustainable fisheries and their contribution to a healthy ecosystem. Describing

and identifying EFH is not an end unto itself; rather, it is the basis for subsequent actions to conserve EFH. Thus, all consultations and conservation measures for fishing and non-fishing activities hinge on the quality and precision of EFH identifications and descriptions. Loosely described EFH can lead to inconsistent or broad interpretation about adverse impacts to EFH and can result in unnecessary controversy about how best to avoid or reduce those impacts. In addition, habitat areas of particular concern (HAPCs) offer a powerful tool for NMFS and the Councils to identify priority areas within EFH for conservation thereby refining the implementation of the EFH management authorities.

Thus, the <u>purpose</u> of this document is to provide guidance to 1) achieve the most refined and precise EFH identifications and descriptions possible using the best available science and 2) maximize the utility of HAPCs as a tool for focusing conservation effort by increasing the consistency and clarity of HAPC descriptions and identification process. The following guidance supplements the EFH regulatory guidelines (50 CFR 600.920) and <u>replaces</u> the "EFH Technical Guidance" (January 2001) and recommendations contained in the May 2001 "Regional Council Approaches to the Identification and Protection of Habitat Areas of Particular Concern \*(03-201-06)"
