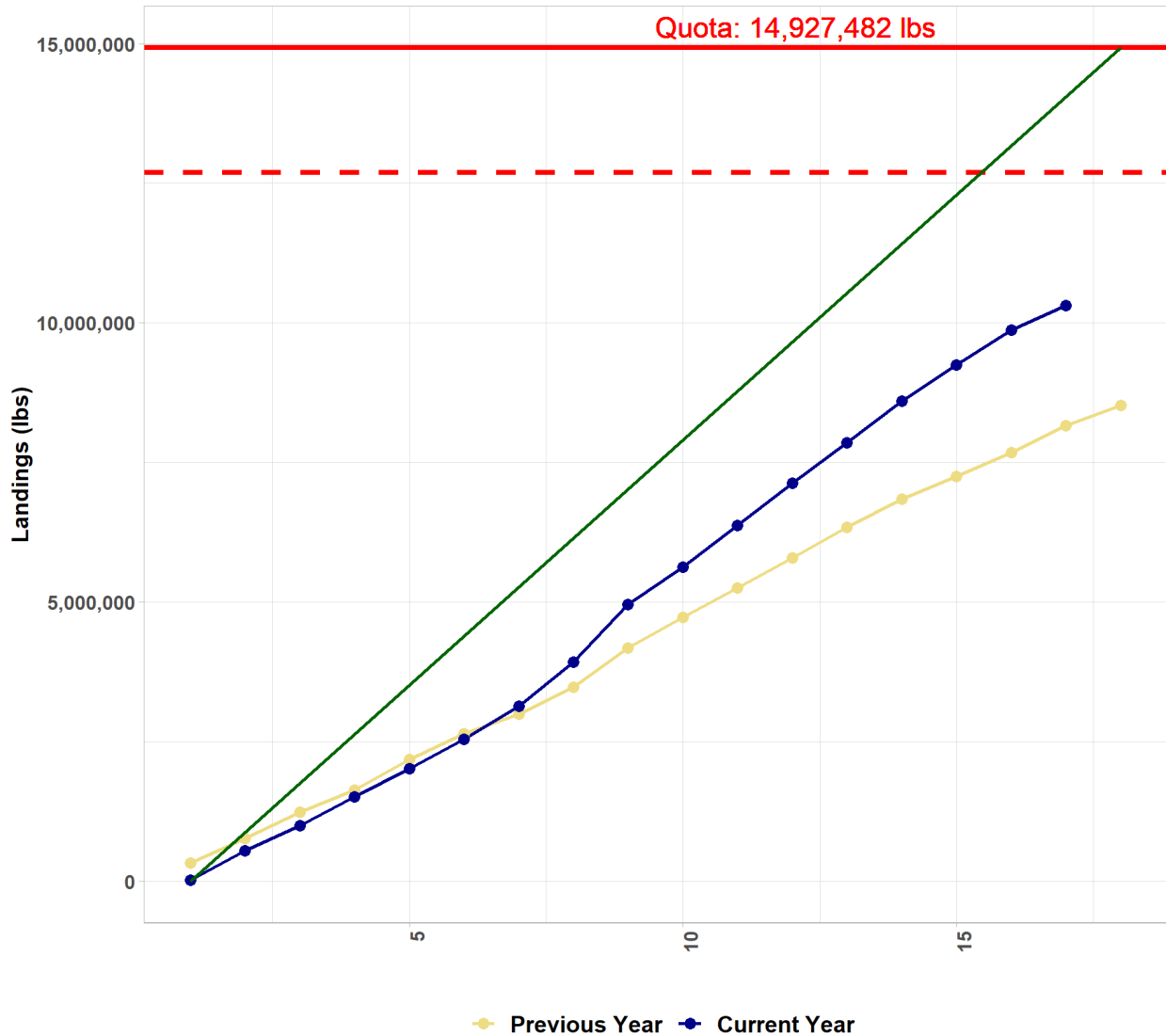

## Notice

The possession limit is 3,000 lb wing weight (6,810 lb whole weight) per trip from May 1 to August 31 and 5,000 lb wing weight (11,350 lb whole weight) per trip from September 1 to April 30 for vessels fishing on a Northeast Multispecies, Monkfish, or Scallop Day-at-Sea (DAS). The Northeast Multispecies Category-B DAS possession limit remains 220 lb wing weight per trip, and the non-DAS incidental possession limit remains at 500 lb wing weight per trip.

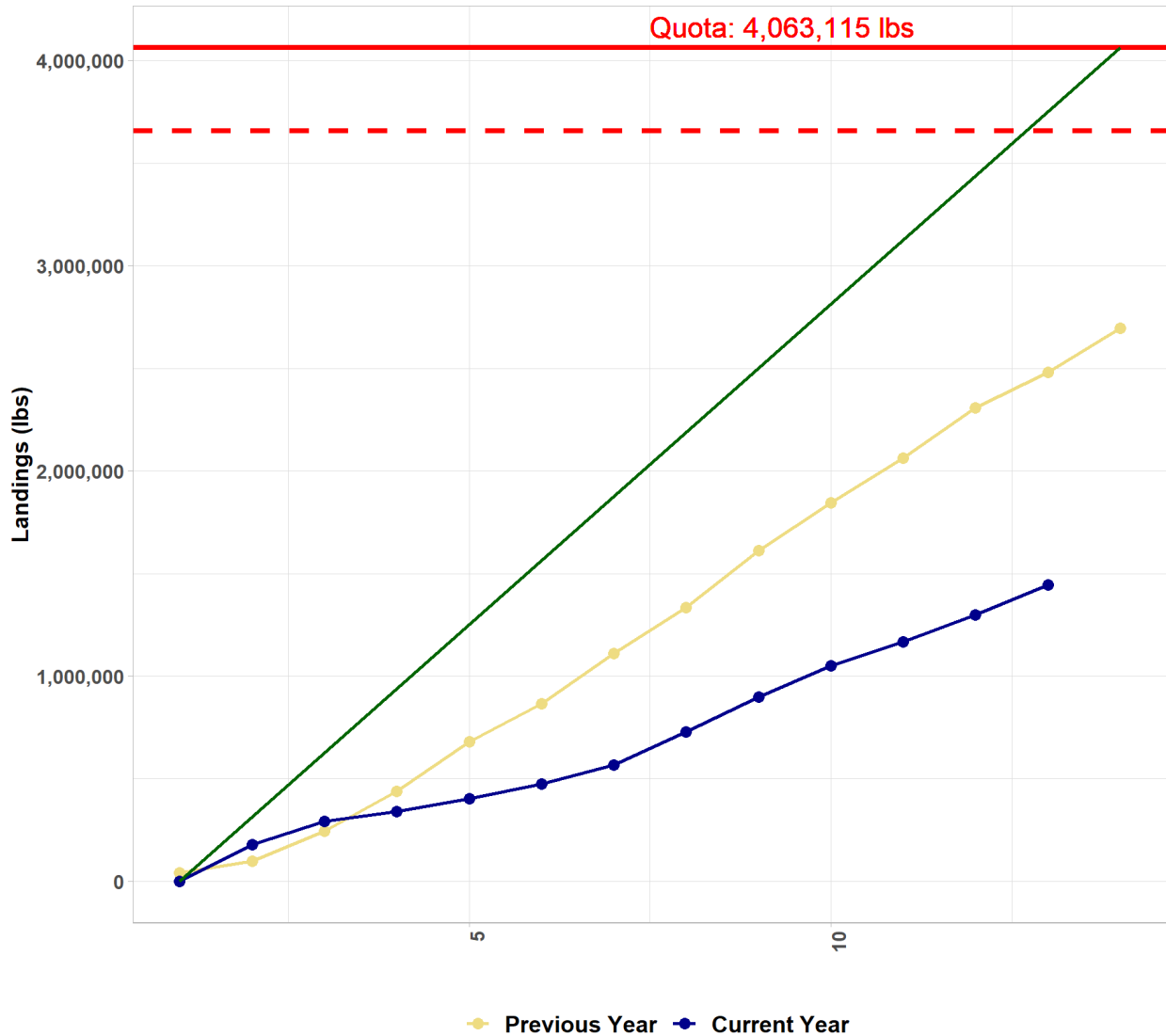

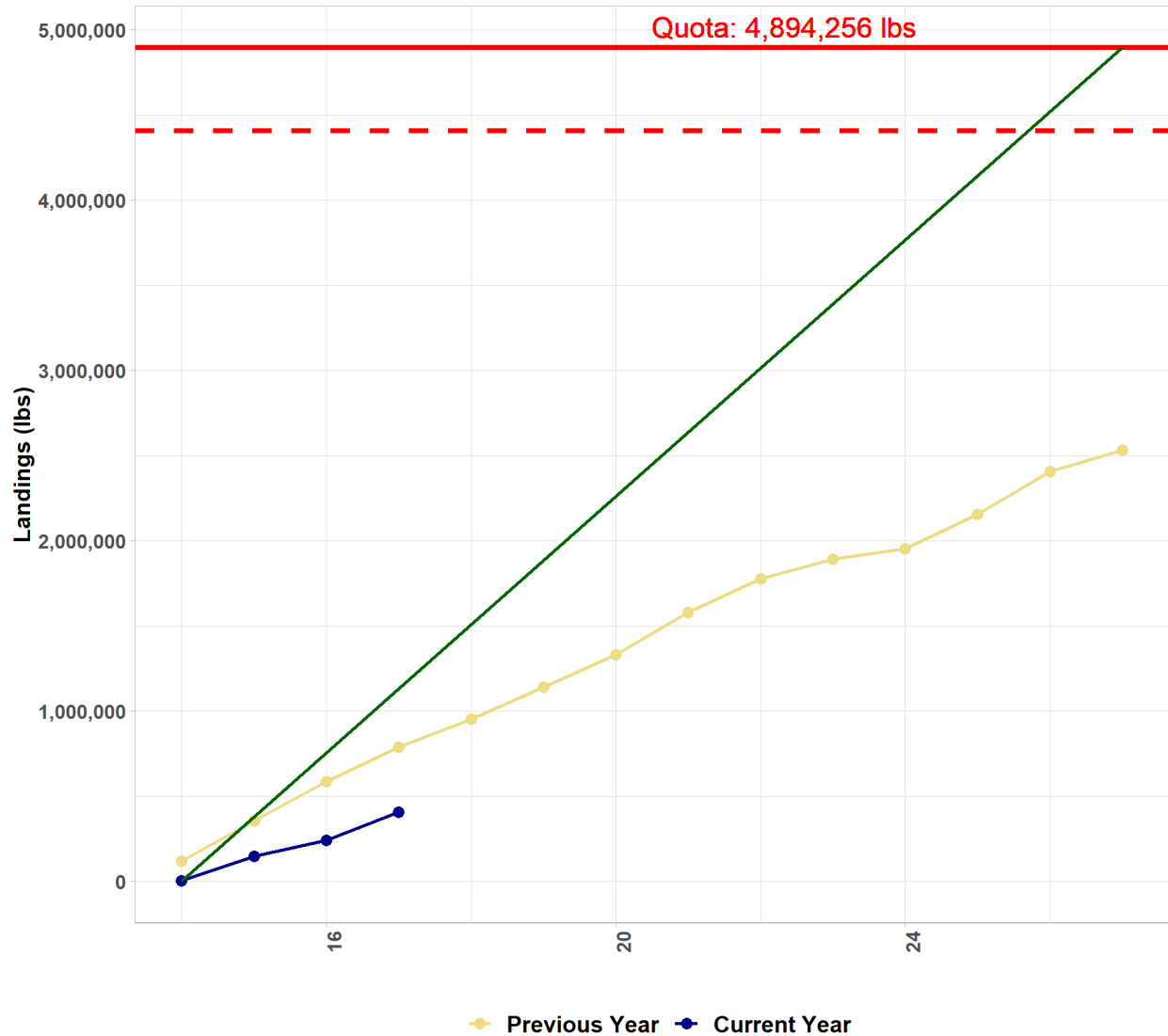
