## NOTICE OF PUBLIC HEARING DRAFT AMENDMENT 23 TO THE NORTHEAST MULTISPECIES FISHERY

The New England Fishery Management Council is conducting several public hearings to solicit comments regarding the range of alternatives under consideration in the Draft Environmental Impact Statement for Amendment 23 to the Northeast Multispecies (Groundfish) Fishery Management Plan. More specifically, the Council is seeking feedback from the public on which alternatives should be selected and why. The alternatives address adjustments to the groundfish monitoring program to improve the reliability and accountability of catch reporting in the commercial groundfish fishery and to ensure the monitoring program is providing accurate catch information. These hearings are being held by the Council in accordance with the National Environmental Policy Act. The Council plans to take final action on the amendment during its June 2020 meeting in Freeport, ME.

This hearing is the first of the series; the remaining hearings will be announced in a separate notice.

Council staff will brief the public on Draft Amendment 23 before receiving comments on the amendment. The hearing will begin promptly at the time indicated above.
