REVISED NOTICE OF PUBLIC HEARING DRAFT AMENDMENT 23 TO THE NORTHEAST MULTISPECIES FISHERY

The New England Fishery Management Council is conducting additional public hearings to solicit comments regarding the range of alternatives under consideration in the Draft Amendment 23 to the Northeast Multispecies (Groundfish) Fishery Management Plan. More specifically, the Council is seeking feedback from the public on which alternatives should be selected and why. The alternatives address adjustments to the groundfish monitoring program to improve the reliability and accountability of catch reporting in the commercial groundfish fishery and to ensure the monitoring program is providing accurate catch information. These hearings are being held by the Council in accordance with the Magnuson-Stevens Act and the National Environmental Policy Act.

The Council plans to take final action on the amendment during its September 2020 meeting.

Three of the four public hearings listed below will have a geographical focus. During these hearings, Council staff will present information on vessel profiles to illustrate example economic costs for the designated states or regions. Participants are encouraged to attend the webinar for their respective state or region but may attend any webinar. Vessel profile information for all states will be provided on the Council website.

Due to the evolving situation with the COVID-19 pandemic, the Council scheduled these hearings as webinars. Additional hearings will be announced in a separate notice.

Written comments received on or before August 31, 2020, as well as comments provided at the hearings, will be reviewed by the Council's Groundfish Committee and full Council at subsequent meetings. Note that this is an **extension** from the previously published comment deadline of June 30, 2020.
