The Monkfish Advisory Panel will meet to:

- Discuss recent monkfish fishery performance and develop a fishery performance report in collaboration with the Plan Development Team
- Develop recommendations for Framework Adjustment 13 to the Monkfish Fishery Management Plan, an action that is likely considering:
 - o 2023-2025 monkfish fishery specifications
 - Other management measures (requiring 12-inch minimum mesh size for monkfish gillnets, requiring use of the Vessel Monitoring System across the federal fishery, measures to reduce discards in the Southern Fishery Management Area)
- Recommend updates for the 2022-2026 NEFMC Research Priorities and Data Needs relative to monkfish
- Discuss other business as necessary
