MEETING NOTICE GROUNDFISH ADVISORY PANEL WEBINAR

Date: Thursday, June 2, 2022

Time: 9:30 a.m.

Agenda: The Groundfish Advisory Panel will meet to discuss:

- **Framework Adjustment 65/Specifications and Management Measures** – discuss development of draft specifications and measures: status determination criteria, rebuilding plans for Gulf of Maine (GOM) cod and Southern New England/Mid-Atlantic (SNE/MA) winter flounder, FY2023-FY2024 US/CA total allowable catches, FY2023-FY2024 specifications: Georges Bank (GB) yellowtail flounder and GB cod (including a catch target for the recreational fishery), FY2023-FY2025 specifications for 14 stocks, additional measures to promote stock rebuilding for GOM cod and SNE/MA winter flounder, and revised acceptable biological catch control rules, in consultation with the Scientific and Statistical Committee.
- **Amendment 23 Review Metrics** – discuss progress on development of metrics.
- **Atlantic Cod Management** - discuss a Council priority to develop a transition plan for Atlantic cod management from the current two management unit to up to five management units (multi-year priority). As a part of the transition plan, there will be a white paper on potential approaches to allocate “Georges Bank cod” to the recreational fishery delivered in 2022 to inform the 2023 priorities discussion.
- **Council Research Priorities** - review the current list of Council research priorities and suggest changes or additions to the list.
- Other business, as necessary.
