### MEETING NOTICE GROUNDFISH COMMITTEE WEBINAR

#### Agenda:

The Groundfish Committee will meet to:

- Receive recommendations from the Groundfish Advisory Panel, Recreational Advisory Panel, and Groundfish Plan Development Team,
- **Framework Adjustment 65/Specifications & Management Measures** - discuss draft alternatives and draft impacts analysis, and make preferred recommendations to the Council for final action to include: status determination criteria, rebuilding plan for Gulf of Maine (GOM) cod, FY2023-FY2024 US/CA total allowable catches, FY2023-FY2024 specifications: Georges Bank (GB) yellowtail flounder and GB cod (including a catch target for the recreational fishery), FY2023-FY2025 specifications for 14 stocks, additional measures to promote stock rebuilding for GB cod and GOM cod, and revised acceptable biological catch (ABC) control rules, in consultation with the Scientific and Statistical Committee.
- **Atlantic Cod Management** - discuss the development of a draft white paper on potential approaches to allocate “Georges Bank cod” to the recreational fishery delivered in 2022 to inform the 2023 priorities discussion and make recommendations to the Council, and
- **Other business**, as necessary.
