The Groundfish Committee, Groundfish Advisory Panel, and Recreational Advisory Panel will meet jointly to discuss:

- **Framework 74 / Specifications and Management Measures (*to be initiated*)** – receive a report on action that is anticipated to include FY2027 specifications for Georges Bank (GB) cod and GB haddock, FY2027-FY2028 specifications for GB yellowtail flounder, FY2027-FY2031 specifications for seven groundfish stocks, FY2027-FY2028 U.S./Canada total allowable catches, modifications to provisions in the southern windowpane flounder accountability measures, and other measures,
- **Framework 68 / Acceptable Biological Catch (ABC) Control Rules** – receive a progress report, including status of the Council's new Risk Policy,
- **Industry updates** - open discussion for advisors to share observations and perspectives on fishery performance from the past year and considerations for the current fishing year,
- **Recreational measures planning** – receive updates from NOAA Fisheries staff on the recreation demand model and decision support tool used to develop recreational measures for Western Gulf of Maine cod and Gulf of Maine haddock, discuss planning for development of fishing year 2027 measures,
- Updates on other Council groundfish priorities for 2026 (if available), and
- Other business, as necessary.
