Framework Adjustment 58- Specifications and Management Measures

Scope

- 1) To revise or establish rebuilding plans for several stocks (Georges Bank (GB) winter flounder, Southern New England (SNE)/Mid-Atlantic (MA) yellowtail flounder, witch flounder, Gulf of Maine (GOM)/GB (Northern) windowpane flounder, and ocean pout),
- 2) To set specifications for fishing year 2019 for U.S./Canada stocks (Eastern GB cod, Eastern GB haddock, and GB yellowtail flounder),
- 3) To exempt vessels fishing exclusively in Northwest Atlantic Fisheries Organization (NAFO) Regulatory Area waters from Northeast Multispecies Fishery Management Plan (FMP) commercial minimum fish sizes, and
- 4) To allow for a temporary change to the Atlantic sea scallop fishery accountability measure implementation policy for the GB yellowtail flounder stock



Objectives

To meet regulatory requirements to prevent overfishing, ensure rebuilding, and help achieve optimum yield in the commercial and recreational groundfish fishery.

List of 2018 Priorities

Annual

- Address allocation issues if raised by new MRIP data
- Get input on different ways to manage recreational fishery in light of highly variable catch estimates: for example, consideration of catch error estimates under MRIP, and errors in bioeconomic model used to determine measures
- Specify allocation review triggers
- Sector five-year review

Multi-Year

- ASM action/Amendment 23 (including work groups/workshops necessary and working group on how fishery dependent data can be used to inform stock abundance).
- Scope limited entry in groundfish party/charter fishery
- Address Status Determination Criteria issue when analytic assessments fail (postponed from annual to multi-year- June Council meeting)
- Cod Stock Structure Working Group

Recreational Advisory Panel

Recreational Advisory Panel Meeting on October 29, 2018

The Recreational Advisory Panel recommends to the Groundfish Committee for 2019 priorities, in ranked order of highest importance:

1. Review the recreational allocations for Gulf of Maine cod and Gulf of Maine haddock using the most recent information from the 2019 assessments, and if determined necessary, make changes through the annual framework action with 2020-2022 specifications.
2. Develop a Recreational Committee/Working Group to focus on groundfish and non-groundfish recreational management issues.
3. Continue to hold listening sessions for possible limited entry for party and charter in the recreational Northeast Multispecies (groundfish) fishery to help the Council determine next steps.
