Fishery: Atlantic Herring Fishery Management Plan (FMP)

Title of Action: Framework 8 to the Atlantic Herring FMP

Scope: Consider fishery specifications for 2021-2023 and consider adjusting herring measures that potentially inhibit the Atlantic mackerel fishery from achieving optimum yield.

Objective of Action:

At its December 2019 meeting, the Council approved the list of 2020 priorities with two items that have been included in this action plan: specifications for 2021-2023 and action to adjust measures in the herring plan that potentially inhibit optimizing yield in the mackerel fishery (i.e. increase in herring incidental possession limit in the range of 2,000-40,000 pounds, modify seasonal closure of Area 1B).

Likely Range of Alternatives:

- Typical measures in a specifications package such as OFL, ABC, ACL, sub-ACL for each herring management area, border transfer, research set-aside, river herring/shad sub-ACLs, etc).
- Measures in the herring plan that potentially inhibit optimizing yield in the mackerel fishery (i.e. increase in herring incidental possession limit in the range of 2,000-40,000 pounds, modify seasonal closure of Area 1B.

Applicable Laws/Issues:

NEPA Analysis (EIS/EA/CE/SIR): This action is expected to require an EA.

Endangered Species Act/Marine Mammal Protection Act: This action is expected to have an informal ESA consultation.
