I. STATUS

- A. <u>Meetings:</u> The Groundfish Committee met on June 4, 2015 to discuss ongoing groundfish actions and management. The Groundfish Plan Development Team (PDT) held meetings on May 12 and 28, 2015.
- B. <u>Amendment 18 Accumulation Limits/Fleet Diversity:</u> The Council submitted A18 to GARFO for preliminary review on May 21, 2015. The public hearing schedule is in development.
- C. <u>Framework Adjustment 53–Specifications and Management Measures</u>: The final rule for this action was published in the Federal Register on May 1, 2015.
- D. <u>Framework Adjustment 54/ Monkfish Framework Adjustment 9:</u> See Monkfish Tab 10 for more information and documents.
- E. <u>Framework Adjustment 55 Multispecies Specifications:</u> The Council is scheduled to initiate this action at its June meeting. The action would set specifications for all groundfish stocks for FY 2016 FY 2018, including the three U.S./Canada stocks for FY 2016.
- F. <u>At Sea Monitoring (ASM):</u> The Council is scheduled to discuss at sea monitoring at its June meeting. The Council will potentially discuss changes to the Groundfish FMP to address industry concerns around the feasibility of the existing requirement that sectors assume some of the costs of the ASM program.
- G. <u>Electronic Monitoring Working Group (reports to Council)</u>: The Electronic Monitoring Working Group (EMWG) held a meeting on April 8, 2015 and a webinar on May 21, 2015. The working group will provide an update on its progress at the June Council meeting.
