


## **New York Bight Lease Areas**

- Lease Sale: February 23, 2022
- Lease Execution: May 1, 2022
- Six lease areas
  - o OCS-A-0544
  - o OCS-A-0537
  - o OCS-A-0538
  - o OCS-A-0539
  - o OCS-A-0541
  - o OCS-A-0542
- New York and New Jersey coast
- Expecting at least 6 Construction and Operations Plans





# Stages of Leasing and Development – Environmental Review Points



## **Objectives of the NY Bight PEIS**

#### Through the development of this Programmatic EIS, BOEM will:

- Analyze regional affected environment and environmental consequences
- Conduct a focused, regional cumulative analysis
- Establish a framework for tiering of project-specific environmental analyses
- Identify, analyze, and adopt (if appropriate) programmatic avoidance, minimization, mitigation, and monitoring measures
- Provide predictability and consistency to cooperating agencies, partners, and developers



# **Tiering Approach**

#### New York Bight Programmatic EIS (Tier 1)

- Overall regional analysis of potential impacts of a representative project
- Identify, analyze, and adopt, where appropriate, programmatic avoidance, minimization, mitigation, and monitoring measures
- Robust cumulative analysis

#### COP-specific NEPA (Tier 2)

- Incorporate the analysis done in the Programmatic EIS by reference where applicable
- Focus on site-specific impacts of approving a particular COP
- Additional avoidance, minimization, mitigation, and monitoring measures
- Approve, approve with modifications, or disapprove the COP


