

The possession limit is 2,600 lb wing weight (5,902 lb whole weight) per trip from May 1 to August 31 and 4,100 lb wing weight (9,307 lb whole weight) per trip from September 1 to April 30 for vessels fishing on a Northeast Multispecies, Monkfish, or Scallop Day-at-Sea (DAS). The Northeast Multispecies Category-B DAS possession limit remains 220 lb wing weight per trip, and the non-DAS incidental possession limit remains at 500 lb wing weight per trip.


