Dear Tom:

We completed our review of the draft supplemental impact report (SIR) for the 2022-2023 Northeast Skate Specifications that you submitted to us on October 27, 2021. The following is a list of issues identified during our review of the SIR that must be resolved to ensure that the document is accurate and consistent with applicable law. We will provide a draft of the SIR document to Council staff with suggested revisions to address these listed issues.

- In Section 4.0, at the top of page 9, the description of the barndoor skate reference point should read: B_{MSY}proxy = B_{target} = the average of the first four years of its survey biomass index.
- Reference to Amendment 5 in Section 5.0 should be updated to reflect the transition to Framework Adjustment 9 and corresponding materials.
- Remove Section 8.13. There are no implementing regulations in this action, and thus there is no Regulatory Impact Review (RIR) required under E.O. 12866.

In addition to the list of issues above, we will provide general comments and suggestions in the draft document to be incorporated at the discretion of Council staff.
