Charter boat/for-hire captains and the recreational anglers they serve, continue to be affected by shortened seasons for many species and zero possession of Cod North of the 42 latitude line (GOM). Recreational anglers want a chance to catch Cod.

Comments on Recreational Cod and Haddock For 2020 Fishing Season

Dear Tom.

I am writing to you regarding the 2020 Gulf of Maine recreational cod season and possession limits. This seems like a yearly writing exercise pointing out the charter and recreational sector are headed down the path of a zero cod possession or a very small bag limit of one fish for two weeks out of a year. During the 2017 season there was no possession of GOM cod, and the 2018 season was a limit of 1 cod per person from Sep 15th to Sep 30th. This resulted in the catch being under the Recreational GOM cod ACL in both years, which left uncaught fish in the water that had been designated to the recreational sector.

As a charter boat owner and the past president of the Stellwagen Bank Charter Boat Association I have experienced and hear of how these small seasons and bag limits have hurt the charter industry which once thrived from Southern Maine to Plymouth during the spring cod and haddock season. Last year we ended up not being able to land the recreational Sub ACL of GOM Cod and this was a direct result of GARFO not allowing a two week spring season for April or May 2020 after the RAP, Groundfish Committee, Council all approved after the NMFS Science Center stated the recreational sector would not exceed the Sub ACL with two additional weeks.


Charter and Head Boats are small businesses which are being hurt by not being allowed to land any cod. Charter and Head Boats move away from areas where there are large amounts of cod to target haddock. MA DMF has maps to help recreational anglers avoid so called cod hot spots which should reduce cod discards. It is time for the RAP and the NEFMC to develop and have the Council and GARFO approve a separate SUB ACL for charter head boats. With the electronic monitoring (EVTRs) that have been forced upon the charter head boat sector it should not be difficult to track how many fish have been landed by the charter party industry and shut it down once the ACL is reached. I am also requesting NMFS provide a spring season in May of 2020 and a two week period in August. This will assist the GOM for hire fleet a bit especially in the spring when there is no striped bass, fluke, black sea bass to target north of Cape Cod.

I appreciate your time and the opportunity to provide comment prior to the RAP and Groundfish Committee meetings.

Dear John.

The Recreational Fishing Alliance, a national 501(c) (4) non-profit political action organization that has been representing individual sport fishermen and the sport fishing industry since 1996, recognizes that the for-hire captains who target groundfish in the Gulf of Maine continue to struggle with the shortened cod season and the one-fish-per-angler cod bag limit Based on preliminary revised MRIP cod landings for 2018 (zero cod possession) and 2019, the recreational sector's total landings were well below the recreational sub-ACL in 2018 and at the approximate sub-ACL in 2019. Prior revised MRIP results were well below the sub-ACL for both 2018 and 2019. Recreational sub-ACL cod are being left in the water while the for-hire fleet continues to be impacted due to an arbitrarily shortened (two weeks in September, in 2019) season.

The for-hire fleet can, and does, avoid cod when targeting other groundfish species. This is reflected in the reduction in their cod landings in 2018 and 2019. In addition, the new MassDMF cod avoidance maps will be available for 2020, which should further assist in additional cod bycatch reductions.

Charter and party boat customers want cod. Many no longer book trips in the GOM, and instead patronize boats south of the 42 latitude line where the cod bag limit is ten per person. The GOM fleet does have haddock, pollock and redfish, but most clients are not interested unless cod are available as well, so many of these vessels sit idle at the dock.

Therefore, the RFA recommends a cod season for two weeks in May and two weeks in August for the for-hire fleet in 2020, with its own season and bag limits, along with status quo for the haddock season and bag limits. With the revised MRIP results now in, it is time to look at the historical landings by the for-hire fleet in order to estimate a cod sub-ACL that we understand would be lower than the total of the other modes. The mandatory use of eVTRs by the fleet should make it possible for the NEFMC and NOAA to effectively manage the fishery with little difficulty. The eVTRs can be monitored on a real-time basis and the fishery could be closed if the for-hire sub-ACL appears that it would be exceeded. The eVTRs need to be used for more than just estimating effort. Private recreational anglers should have their own season(s) and bag limits that work for them.

Thank you very much for your consideration, and we hope the NEFMC will discuss, and move forward with, this proposal in a timely manner.

Dear John/Tom:

The charter boat/for-hire captains of the Stellwagen Bank Charter Boat Association continue to struggle with the shortened cod season and the one fish per angler cod bag limit in the WGOM. Based on preliminary revised MRIP cod landings for 2018 (zero cod possession) and 2019, the recreational sector's total landings were well below the recreational sub-ACL in 2018 and at the approximate sub-ACL in 2019. Prior revised MRIP results were well below the sub-ACL for both 2018 and 2019. The Commonwealth of Massachusetts, Division of Marine Fisheries recommended a one-cod bag limit in 2018, yet NOAA was adamantly against the proposal and a zero possession cod limits was implemented, resulting in cod landings that were well below the sub-ACL. We are leaving cod in the water while the for-hire fleet struggles.

The for-hire fleet moves to other areas if cod are encountered while targeting haddock during closures. This is reflected in the reduction in cod landings in 2018 and 2019. Unless the cod season is open (such as the short period of time in September, 2019), we avoid cod when we target haddock. The new MassDMF cod avoidance maps will be available for 2020, which should further assist in additional cod bycatch reductions while we target other groundfish species.

Ultimately, the for-hire fleet is struggling. Our clientele wants cod. Many customers no longer book trips in the GOM, and instead patronize boats south of the 42 latitude line where the cod bag limit is ten per person. Yes, we have haddock, pollock and redfish in our waters, but most clients are not interested unless cod are available as well. Our historical and preferred cod season is April and May, when there are few

other species to target as striped bass and bluefin tuna have not yet arrived in our waters.

Therefore, we recommend a cod season for two weeks in May and two weeks in August for the for-hire fleet, with our own season and bag limits, along with status quo for the haddock season and bag limits. With the revised MRIP results now in, it is time to look at the historical landings by the for-hire fleet in order to estimate a cod sub ACL that is significantly less than the other modes (recreational angler, boat and shoreside). The mandatory use of eVTRs by the fleet should make it possible for NOAA to manage the fishery with little difficulty. Monitor our eVTRs and shut us down early if need be so that our sub-ACL will not be exceeded. The eVTRs need to be used for more than just estimating effort. Private recreational anglers can have their own season(s) and bag limits that work for them.

Dear Tom:

We recently completed the groundfish year-end accounting for the 2018 fishing year. We sent you a letter conveying the draft report on November 4, 2019, but it did not include the finalized catch accounting for Atlantic halibut. The final report is attached to this letter.

In fishing year 2018, the total annual catch limit (ACL) for Atlantic halibut was exceeded by 3.3 percent, or 3.3 mt. However, the overage was not greater than the management uncertainty buffer, and therefore the halibut accountability measure is not triggered. Table 1 summarizes the Atlantic halibut ACL overage.

Thank you for providing the New England Fishery Management Council the opportunity to comment on the DRAFT tech memo titled "National Standard 1 Technical Guidance for Designing, Evaluating, and Implementing Carry-over and Phase-in Provisions within ABC Control Rules". As requested, the Council developed its comments in consultation with its Scientific and Statistical Committee (SSC).

Our Council believes that allowing ACL and ABC carryovers can be very beneficial, as long as the carryovers do not cause overfishing in the subsequent year. It believes that carryover provisions like those implemented under the Atlantic Scallop and Northeast Multispecies provide adequate safeguards to avoid overfishing and provide important safety and flexibility benefits for these fisheries.

Allowing a phase-in policy of fishing reductions needed to end overfishing also could be beneficial in terms of reducing economic and social impacts on the fishery under some circumstances, and our Council believes that the policy guidance provides a useful framework for evaluating whether a phase-in is appropriate.

One issue that should be considered in the development of National Standard 1 guidance is how councils should develop ABCs and ACLs for stocks that no longer have an accepted assessment and for which the OFL cannot be determined. I mention that in these comments because the lack of an agreed upon OFL also could affect carryovers and phase-ins.

Additionally, there is an error in the example that is provided for how carryover provisions might apply in the Atlantic Scallop FMP. The scallop ACLs that are proposed in each framework adjustment for updating scallop specifications and the final rule published by NMFS do not include carryover values because they are not known at that time.

RE: Framework Adjustment 59 to the Northeast Multispecies FMP

Dear Dr. Quinn and Mr. Nies:

Conservation Law Foundation (CLF) submits this letter to the New England Fishery Management Council (Council) regarding Framework Adjustment 59 to the Northeast Multispecies Fishery Management Plan (Framework 59), specifically the specifications for Gulf of Maine cod (GOM cod) and Georges Bank cod (GB cod) in fishing years (FY) 2020-2022. CLF has a long history of advocating for sustainable fisheries in New England, and we are increasingly concerned about the failure to end overfishing immediately and rebuild these stocks as quickly as possible consistent with legal requirements of the Magnuson-Stevens Act (MSA). We urge the Council to propose specifications for GOM cod and GB cod that end overfishing and place these stocks on appropriate rebuilding trajectories.

Legal Mandate

As set forth in National Standard 1, the primary mandate of the MSA is to prevent overfishing: "Conservation and management measures shall prevent overfishing while achieving, on a continuing basis, the optimum yield from each fishery for the United States fishing industry." To do so, the MSA requires annual catch limits and accountability measures that end overfishing "based upon the best scientific information available." Further, for overfished stocks such as GOM cod and GB cod, conservation and management measures must be implemented "to end overfishing *immediately* in the fishery and to rebuild affected stocks of fish." To date, the Council has repeatedly proposed specifications for Atlantic cod stocks that do not achieve these legal mandates.

Best Scientific Information Available

Both GOM and GB cod stocks are overfished with overfishing occurring,⁴ despite being in rebuilding plans (two for GOM cod) since 2004. The best scientific information available, including the 2019 operational assessments, demonstrate that they have been subject to overfishing for 100 percent of the time periods covered by the assessments (GOM cod: 1982-2018, GB cod: 1978-2011) and have been overfished for all but two years.

GOM cod lingers at historic low population levels that are only 6 to 9 percent of its spawning stock biomass target. In addition to a decline in stock size and geographic range, GOM cod also exhibits a severely truncated age structure, which is indicative of a population experiencing high fishing pressure and lack of recruitment. Recruitment remains near record low, with little positive signs of incoming recruitment, guaranteeing that the stock will not meet its 2024 rebuilding date. In fact, five years into the ten-year rebuilding plan, there is only a 0 to 1 percent chance that GOM cod will rebuild on schedule even under a no-fishing scenario; that is a 26-fold decrease in probability of rebuild in just the last two years.

GB cod fairs no better. Based on the last accepted estimate, the stock was only 7 percent of its spawning stock biomass and experiencing overfishing. ¹¹ Recent survey indices, the primary basis for assessing the fishery without an accepted analytical model, confirm low abundance. ¹² The stock also exhibits a severely truncated age structure. ¹³ Although precise projections cannot be made, there is no reason to expect that GB cod will meet its 2026 rebuilding date.

FY 2020-2022 Specifications

To comply with the MSA, the Council must propose in Framework 59 FY 2020-2022 specifications for GOM cod and GB cod that end overfishing immediately and place these stocks on appropriate rebuilding trajectories.

For GOM cod, a stock that cannot rebuild on schedule even without fishing, the ABC control rule is unequivocal: "For stocks that cannot rebuild to B_{MSY} in the specified rebuilding period even in the absence of fishing, the ABC should be based on incidental bycatch, including a reduction in the bycatch rate (i.e., the proportion of the [cod] stock caught as bycatch)." Given the current status of GOM cod, there is no rationale for the Council to deviate from the ABC control rule. ABCs set at 75%F_{MSY}, as suggested by the SSC for Framework 59, have repeatedly failed to end overfishing. Further, the SSC relied on anecdotal economic considerations – not relevant to the legal requirement to end overfishing immediately – to recommend an ABC that was even higher than the default control rule. In Framework 59, the Council must propose FY 2020-2022 ABCs, and subsequent ACLs, for GOM cod based on incidental catch, including a reduction in bycatch rate, to end overfishing immediately and support rebuilding of the GOM cod stock as required by the control rule and the MSA.

For GB cod, the Council should use the utmost caution when proposing specifications given the inability to quantifiably assess the stock. To that end, at a minimum, the Council should reject the Groundfish Committee's recommended ABC, which was derived by an inconsistent utilization of the empirical approach compared to previous years. During the 2015 operational assessment for GB cod – when the analytical model was rejected – "the Operational Assessment Panel recommend[ed] that the *overfishing limit (OFL)* should be a proportion of the most recent 3-year average catch, and that proportion should be determined by recent survey trends." Using the proportion of the most recent 3-year average catch to recommend *an ABC*, *not an OFL*, as the SSC and Groundfish Committee have done, is inconsistent with the original intent of this approach and removes a critical scientific uncertainty buffer for the stock, as described in the SSC's minority report. 16

Ultimately, however, the empirical approach (and the specifications derived from it) has repeatedly shown itself as being inadequate to end overfishing immediately and rebuild the GB

cod stock. Therefore, it should not be used to propose FY 2020-2022 specifications in Framework 59. Given the continued overfished status and known chronic overfishing of GB cod, as well as the stock's unlikely ability to rebuild by 2026, CLF asserts that there should be no directed fishery for this stock. As with GOM cod, specifications should be based on incidental catch with measures to reduce bycatch rate over the FY 2020-2022 period.

Lastly, the Council should consider how to comprehensively address the biases and uncertainties that have resulted from the lack of adequate monitoring in this fishery. As it is currently impossible to set specifications using accurate and precise data, completing Amendment 23 should be the Council's highest groundfish priority in 2020.

But I also know that a substantial increase in coverage coupled with the shift of financial responsibility to the fleet would, at least to the part of the fleet I am involved in,make operations financially untenable, leaving myself and others unable to support our families.

It's my understanding that electronic monitoring would put the responsibility of sorting by-catch on the vessel and crew. Although this is a small percentage of our catch it would still be an increased burden in terms of time, labor and expense Over years, first because of lack of fish.and now because of lack of quota, vessels have had to cut back on personnel to remain solvent. Operations that employed 3-4 people now employ 2 and many fish alone.

Recently, due to good management and strict compliance by the fleet, there has been resurgence of several fish stocks. This is seasonal in nature and due to it's seasonality does not promote the hiring of additional personnel. At times this leaves 1 and 2 person vessels doing the work that took 3-4 people in the past. Sorting and attempting to return by-catch to sea in a timely manor would undoubtedly increase fatigue. Fatigue's consequences are lapses in procedure and mental awareness. I have been both witness and victim to this and it is dangerous.

These are facts that will likely be ignored, for it has been stated by some in management that they have neither the time nor the inclination to listen to small stakeholders, the people that built industry, or dissenting views The die has been cast consolidation is coming, in fact it's well on it's way An industry that for generations has prided itself on hard work and independence is going the way of the dinosaur and all in the management industry either through advocacy or by complacency will be complicit in it's demise
