SKATE COMMITTEE REPORT

Framework 9

1. Committee consensus statement:

that the word "skate" be inserted between the words "encourage research" in Objective 5. The resulting language would read:

"Promote and encourage **skate** research for critical biological, ecological, and fishery information based on the research needs identified and updated by the Council."

HABITAT COMMITTEE REPORT

4. Mr. Reid moved on behalf of the committee:

that the Council initiate a Framework to develop a Habitat Area of Particular Concern (HAPC) in Southern New England, with the following problem statement: A new HAPC in Southern New England is needed to provide conservation focus for specific New England Fishery Management Council managed species with essential fish habitat in the

area. This is due to concerns about impacts from offshore development, specifically offshore wind in the near term, and possibly offshore aquaculture in the future.

Great South Channel Habitat Management Area

5. Dr. Sissenwine moved and Mr. Olszewski seconded: that the Habitat Committee supported by the Plan Development Team review the results of Coonamessett Farm Foundation's clam dredge mapping study, conducted in a subset of the Rose and Crown area under an Exempted Fishing Permit (EFP), once a report has been provided to the Council. The purpose of this review is to ascertain the utility of this study for management of fishing gear impacts within the Great South Channel Habitat Management Area. This assessment could be used to support NOAA Fisheries consideration of an extension for this EFP, or approval of similar EFPs.
