Recreational Measures for Fishing Year 2020: Gulf of Maine cod and Gulf of Maine haddock

Motion 1: Bellavance/Godfroy

The Groundfish Committee recommends to the Council for fishing year 2020 recreational measures:

Gulf of Maine cod

• Open Season: September 15-30 and April 1-14

• Bag Limit: 1 fish

• Minimum Size: 21 inches

Gulf of Maine haddock

• Open Season: May 1 – February 28 and April 1-30

• Bag Limit: 15 fish

• Minimum Size: 17 inches

Motion 2: Bellavance/Godfroy

The Groundfish Committee recommends to the Council to adjust the fishing year 2019 recreational measures as:

Gulf of Maine cod

• Open Season: September 15-30 and April 1-14

• Bag Limit: 1 fish

• Minimum Size: 21 inches

Gulf of Maine haddock

• Open Season: Year-Round

• Bag Limit: 15 fish

• Minimum Size: 17 inches
