Extension of Emergency Measures for the Northeast Multispecies Fishery

On October 3, 2025, NMFS published a rule to extend the emergency measures implemented for the Northeast Multispecies FMP on May 2, 2025. This action was necessary to address an emergency presented by an absence of approved specifications and other measures for fishing year 2025. This rule extends all emergency measures in the May 2, 2025, emergency rule, and updates sector and common pool allocations to reflect the final rosters that were not available when the emergency rule was originally implemented. Herring

2025 New Brunswick Weir Adjustment

On November 18, 2025, NMFS published a temporary rule (90 FR 51570) increasing the herring Area 1A sub-ACL (annual catch limit) from 783 to 1,783 mt and the ACL from 2,710 to 3,710 mt for the remainder of 2025. Because herring landings in the New Brunswick weir fishery were less than 2,722 mt through October 1, NOAA Fisheries is required by the regulations implementing the Atlantic Herring Fishery Management Plan to subtract 1,000 mt from the management uncertainty buffer and to reallocate it to the herring Area 1A sub-ACL and the ACL. This adjustment is effective November 17, 2025 through December 31, 2025 or until fully harvested. Summer Flounder, Scup, and Black Sea Bass

Massachusetts Commercial Summer Flounder Fishery Closure

Effective November 7, 2025, NMFS closed the summer flounder commercial fishery in Massachusetts through December 31, 2025 (90 FR 50490). This action was triggered because the 2025 commercial summer flounder quota allocated to Massachusetts has been harvested. The Massachusetts Division of Marine Fisheries closed the state fishery starting on October 25, 2025. Blueline Tilefish Commercial Closure

Effective November 10, 2025, NMFS closed the blueline tilefish commercial fishery through December 31, 2025 (90 FR 50743). This action was triggered because blueline tilefish commercial landings exceeded 100 percent of the annual Total Allowable Landings (TAL). On July 11, 2025, NMFS had reduced the commercial possession limit in order to slow landings and keep the commercial fishery open as long as possible. Mackerel, Squid, and Butterfish

2025-2026 Mackerel, Squid, and Butterfish Specifications

On September 23, 2025, NMFS published a final rule in the *Federal Register* (90 FR 45674) implementing 2025-2026 specifications for the Mackerel, Squid, and Butterfish Fishery Management Plan. This action sets 2025 and projects 2026 specifications for the butterfish fishery, and reaffirms previously-projected 2025 specifications for the Atlantic mackerel, chub mackerel, *Illex* squid, and longfin squid fisheries. This action also reduces the minimum size for square mesh used on directed butterfish trawl trips from 3 inches to greater than 2 % inches. The effective date for this rule is October 23, 2025. Quota Transfers

On September 29, 2025, NMFS published a temporary rule in the *Federal Register* (90 FR 46528) to increase the commercial scup possession limit and quota for the Winter II season. The temporary rule transfers unused Winter I quota to Winter II, and increases the possession limit based upon the amount of quota being rolled over, as described in the final rule for 2025 Summer Flounder, Scup, Black Sea Bass, and Bluefish Specifications (December 10, 2024; 89 FR 99138). Effective on October 1, 2025, the Winter II quota will be 4,162,331 lb, and the possession limit will be 15,000 lb per trip.
