# Rulemaking/Notices since the Spring 2021 AP Meeting

#### **Final Amendment 12**

- 1) Revises some objectives in the 2006 Consolidated HMS FMP
- 2) Adopts the International Commission for the Conservation of Atlantic Tunas (ICCAT) stock determination criteria for ICCAT-managed HMS
- 3) Reviews the HMS standardized bycatch reporting methodology (SBRM)
- 4) Establishes triggers for review of allocations of quota-managed HMS
- 5) Notifies the public of modified timing for release of the HMS Stock Assessment and Fishery Evaluation (SAFE) Report

No implementing regulations -- any resulting operational changes to fishery management measures would be considered in future rulemakings, as appropriate

Notice of Availability published August 20, 2021 (86 FR 46836)



# **Amendment 14 (Atlantic Shark Fisheries)**

- Comment period on draft Amendment 14 ended Dec. 31, 2020
  - Received 10 written comments and numerous oral comments from webinars, council meetings, and AP meeting
  - Overall, there was support for preferred management options, but some concern Amendment 14 contains neither specifics on the acceptable biological catch (ABC) control rule, nor details of how the fishery will be actively managed
- HMS and SEFSC staff are working on ABC control rule specifics
- Plan to release the revised ABC control rule portion and accept comments in the fall
- Final Amendment 14 anticipated to be released in 2022



# **2022 Proposed Shark Specifications**

- Commercial shark fishing year would open on January 1, 2022 for all shark management groups
- Commercial retention limit would start at 55 large coastal sharks other than sandbar sharks per vessel per trip for all regions
- Commercial retention limit for blacknose sharks would start at 8 sharks per vessel trip
- Public comment closed on September 7
- Final Rule expected to file in November or December 2021



#### Maine/ATCA Final Rule

Added Maine to the list of states at 50 CFR 635.1(b) for which Federal Atlantic tunas regulations are applicable within state waters under the Atlantic Tunas Convention Act

- Applicable regulations include all part 635 tunas regulations, including: open and closed seasons, retention limits, size limits, authorized gears and gear restrictions, and permitting and reporting requirements
- Atlantic tunas managed under these regulations: bluefin, bigeye, albacore, yellowfin, and skipjack tunas
- Rule responsive to a request from Maine Dept. of Marine Resources

# Litigation: Amendment 5b/Dusky Shark

- In March 2021, the District Court for the District of Columbia upheld Amendment 5b, which addressed dusky shark overfishing and rebuilding
- Oceana has appealed the decision to the D.C. Circuit
- Appellate briefing starts in October 2021



# Litigation: PLL Bluefin Tuna Area-Based and Weak Hook Management Measures

- Lawsuit filed by EarthJustice, on behalf of Healthy Gulf and Turtle Island Network
- Filed on April 29, 2020
- Administrative record filed June 18, 2020
- Supplement to the record filed August 25, 2020
- Briefing completed in December 2020
- Awaiting judge's ruling



# 2021 Appropriations Act Joint Explanatory Statement (JES) – Spring Gulf of Mexico Monitoring Area

- Language in the JES directed NOAA Fisheries to reconsider the Gear Restricted Area/Weak Hook (GRA/WH) Rule decision to open the Spring Gulf of Mexico Monitoring Area or to increase monitoring in the area
- NOAA Fisheries published a public request for any information not considered in development of the final rule
- NOAA Fisheries accepted comments and information from June 15 through July 15 and held two public webinars
- Bluefin tuna catch data is posted on the <u>GRA/WH rulemaking page</u>
- NOAA Fisheries is reviewing information submitted and determining next steps



### Electronic Reporting (eReporting) & Future Rulemaking

HMS Management Division is involved with the One Stop Reporting (OSR) initiative to create and streamline vessel eReporting (i.e., accommodate reporting requirements for multiple fisheries in different regions)

- Streamline eReporting for vessels that have multiple permits
- Timeline driven by GARFO need for system by November 2021
- Currently, eTrips program fulfills reporting requirements associated with GARFO, HMS handgear, and SEFHIER fishing permits
- In near future the Southeast Coastal Fisheries and HMS Logbooks requirements will also be included in eTrips
- HMS Management Division is reviewing how permit holders will be impacted; more information will be forthcoming



# **Online Workshops**

- NOAA Fisheries anticipates implementing online recertification workshops in the fall of 2021 for persons who have already attended an in-person workshop
- This option will be available for both the Safe Handling, Release, and Identification workshop and the Atlantic Shark Identification workshop
- In-person workshops will continue to be conducted, but at a reduced frequency
- Permit holders will be notified of this option when it becomes available this fall

NOAA Research Cruises continue to collect data. <u>Includes the</u> NEFSC BLL cruise, which caught ~2,500 sharks

- Atlantic Large Whale Take Reduction Plan Phase 2 (Modifications including for gillnet fisheries): Notice of intent published 8/11/21; scoping period ends 10/21/21
- Pelagic Longline Take Reduction Plan Changes: Proposed rule published 12/15/2020

### There is a lot happening outside the HMS Division

#### Some other things might impact HMS fisheries

- Expansion of Florida Keys National Marine Sanctuary: DEIS and Restoration Blueprint released 8/20/19 and comment period ended 1/31/2020
- Aquaculture: Southeast Region planning team (Aquaculture Opportunity Areas, other projects)
- Modification of Fishing Access in Eastern Gulf of Mexico MPAs (Madison-Swanson / Steamboat Lumps): Request for commensurate regulations for Atlantic HMS from the Gulf Council
- <u>NE Canyons and Seamounts</u>: Pursuant to E.O. 13990, Sec. of Interior must review the June 5, 2020 Presidential Proclamation that lifted the prohibition on commercial fishing in the Canyons and Seamounts Marine National Monuments

# Report on Limited Access Privilege Programs (LAPPs) in Mixed-Use Fisheries

- Modern Fish Act of 2018 instructed the National Academies of Sciences, Engineering, and Medicine (NASEM) to examine the effects of LAPPs in mixed-use fisheries (i.e., commercial, recreational, charter)
- LAPP fisheries examined included the Individual Bluefin Quota (IBQ) program as well as the red snapper, grouper-tilefish, golden tilefish, and wreckfish Individual Fishing Quota (IFQ) programs
- General findings: strong evidence IFQs reduce the race to fish and increase fishery profitability; some evidence they reduce wasteful fleet overcapacity; no evidence they have led to fleet consolidation or of direct effects on private or for-hire recreational sectors
- Found strong evidence the IBQ program has ecological benefits from reduced discards and bycatch by incentivizing avoidance (i.e., encouraging vessels to avoid bluefin)

## **U.S./Bahamas Boundary Information**

- At the May 2021 AP meeting, there were questions about boundary location and rules for recreational fishing/transiting following <u>news</u> of a case involving illegal harvest of commercial quantities of reef fish from Bahamian waters
