#### **MEMORANDUM**

**SUBJECT:** 20198 Council Priorities

- 1. The attached documents are to help the Executive Committee develop recommendations for 2019 Council priorities. I will update enclosure (1) for the Council meeting to reflect the Executive Committee recommendations.
  - a. The first attachment lists identified possible tasks. Tasks are listed by FMP, with tasks that should be completed by the end of the year in the first column and multi-year tasks in the second column. My advice for Executive Committee recommendations are marked with a checkmark. Tasks that I do not recommend are also in italics. The list includes major staff tasks that are expected to occur. My recommendations assume that most multi-year tasks in progress will continue until completed, and that all regulatory requirements will be addressed. While in some cases tasks are grouped into packages, these are tentative and can be changed once priorities are established.
  - b. The second attachment summarizes the prioritization of the tasks by Council members. The prioritization and other issues are discussed below.
- 2. Not all Committees have had an opportunity to identify their preferred priorities for 2019.

#### **Resource Use**

3. The results of the priority exercise guide how the Council uses its resources, so it may be useful to look the previous year's expenditures. Figure 1 below summarizes our resource use from 1 October 2017 through 30 September 2018. Meeting and contract expenses were summarized by topic, Council costs were allocated to topics by the amount of actual time spent on each topic (last year's report used scheduled time), and personnel costs were assigned based on staff tasking.

#### **Prioritization Exercise**

- 4. In an effort to help the executive Committee allocate Council resources, each Council member was asked to rank each task as a high, medium, or low priority task. Seventeen of eighteen Council members replied, but some respondents did not rank every task. The ratings were converted to a score (high=3, medium = 2, and low = 1), summed for each task, and the tasks ranked in order. The average score (36.2) and standard deviation (SD) (7.4) across all tasks was calculated. Given the standard deviation, scores within a few points of each other do not reflect a difference in importance as evaluated by the Council. The SD for each task was also calculated. Lower SDs for a task could be interpreted as indicating more agreement on the task's ranking; higher SDs indicate less agreement on the task's importance. Perfect agreement would result in an SD of 0; an even distribution (4 high, 6 medium, 4 low) results in an SD of 0.82, and an even split (8 high, 8 low) results in an SD close to 1.
- 5. There are a few observations worth noting from this ranking exercise.
  - a. There is general agreement among Council members on the importance of the top fifteen tasks. With a few exceptions, there is also general agreement on the relative importance of the bottom five or ten ranked tasks.
  - b. Tasks with the highest SD (over 0.8) include some that were ranked above average and some below average. This high SD indicates a divergence of opinion among Council members on the importance of these tasks.
  - c. The above average task with the greatest divergence of opinion was Whiting Amendment 22. This was similar to last year's evaluation of this task.
  - d. Several tasks with a below average score had high SD, indicating a strong divergence of opinion on their importance. The most polarizing task was the consideration of a Recreational Committee. Consideration of party/charter limited entry, the multispecies sector five year review, harvest of slow-growing scallops in the NLCA, and whiting exemption area adjustments also showed a divergence of opinions.

e. While Council members were asked to rank all tasks, some are not discretionary, even if ranked low.

### Groundfish

- 6. The highest-ranked groundfish priorities are ASM amendment and annual specifications. There is little interest on the Council in pursuing party/charter limited entry, a GB cod sub-ACL for the recreational fishery, or the five-year sector review.
- 7. After every cod assessment, the issue of stock structure surfaces. The Atlantic Cod Stock Structure Working Group has been meeting this year, but Council member interest in the topic is waning.
- 8. Recreational issues generally did not rank highly, but I recommend allocation issues raised by MRIP be addressed, consistent with Amendment 16.

#### Monkfish

9. Specifications for 2020-2022 need to be specified this year.

## **Sea Scallops**

- 10. While there is general agreement on the importance of the top scallop task (specifications and management measures for 2020) there is more divergence of opinion on the other tasks.
- 11. The second-ranked scallop task was "Action to modify scallop access areas to be consistent with OHA2 revised areas." I do not recommend pursuing this task as it has already been addressed through a recent framework action. Perhaps additional clarification is needed on what the Committee means this task to address.
- 12. The Scallop Committee added a possible task: "Action to mitigate impacts on yellowtail flounder." This was not ranked by Council members.
- 13. As in all recent years, the Scallop Committee recommended only one year of specifications (with a second default year). We have fallen into the practice of adjusting scallop specifications each year even though the FMP and the regulations call for a two-year cycle. This inhibits the ability of the Committee and PDT to address other scallop management issues. It also increase uncertainty for the industry, as the annual adjustments cannot be determined until late fall and adjustments may not be implemented by the start of the fishing year. The Executive Committee may want to encourage the Council to revisit a biennial adjustment process. One idea that may be worth considering is a two-year cycle with an annual review to see if an adjustment is warranted.

## Herring

- 14. Staff will be completing Amendment 8 early in the year. There will also be an action for specifications for 2020 and beyond.
- 15. ASMFC asked the Council to consider developing spawning closures on Georges Bank. This request was received after the September Council meeting and was not ranked by Council members.

#### **Habitat**

- 16. Staff will be working early in the year to complete two recent actions: the Deep Sea Coral Amendment and the Surf Clam framework.
- 17. Revisiting the Habitat Management Areas on the Northern Edge of Georges Bank drew little enthusiasm from Council members and was ranked in the bottom third of possible tasks. If the Council decides to pursue this action, the impacts on scallop priorities will need to be considered.
- 18. Addressing offshore energy issues place steadily increasing demands on the staff. We are expecting a rapid succession of proposals that the Council will wish to comment on. There is also Council interest in a joint NEFMC/MAFMC win energy workshop, but it is not clear what the workshop would be designed to accomplish. Staff is discussing this idea with the MAFMC but it not ready to make a recommendation.

## Whiting/Small Mesh Multispecies

19. Completion of the whiting limited entry program will compete for staff time with the EFBM fishery ecosystem plan early in the year. There is general support for addressing southern red hake rebuilding requirements and several other small-mesh issues.

### **Skates**

20. Much like last year, the Council shows little interest in developing a limited entry program for the skate fishery. The Executive Committee may want to discuss whether to continue this project. The Council has initiated a flurry of skate frameworks in recent years to address management concerns that arguably are related to the lack of a limited entry system. Skate specifications will also need to be completed this year.

## **EBFM**

21. Work will continue on the fishery ecosystem plan. The Executive Committee may want to discuss the pace of this action. The last EBFM Committee meeting was in June 2018, and the next one will not be until January 2019. The slow development and lack of Council discussion suggests a discussion of the Council's interest is warranted.

## **Trawl Survey Advisory Panel**

22. Unlike last year, this AP was ranked above average by Council members. Because the panel is staffed by the MAFMC with funding from the NEFSC, participation does not tax Council staff.

## **SSC**

23. The SSC will continue to advise the Council on OFLs/ABCs. It may be helpful if the SSC continues its effort to develop a consistent approach to Plan B assessments (i.e. catch advice when analytic assessments fail).

#### Other

- 24. The Council ranking exercise revealed little appetite for two tasks delegated by NMFS: the five year review of the Northeast Multispecies sector program and the identification of allocation review triggers. These are important tasks that cannot be delayed indefinitely. The Executive Committee will bring forward a recommendation on Allocation Review Triggers at the January Council meeting. Council and NMFS staff have been coordinating efforts on the sector five year review and progress is expected this year.
- 25. There are several lawsuits pending that could trigger future Council action. It appears doubtful any of these suits will be resolved early in the year.
- 26. Review and implementation of the NEFMC Program Review recommendations will be discussed at the Executive Committee meeting and should be considered as priorities are reviewed.

### Grouping

27. Enclosure (1) does not group all tasks into management actions. There could be changes made to these suggestions after the Council makes its decisions.
