Rulemaking and Inseason Actions (2025)

As of mid-August:

- Several HMS-specific actions completed including:
 - 2025 shark specifications
 - 11 inseasons (all bluefin tuna)
 - 4 meeting notices
 - 1 proposed rule (mobulids)
- Several actions are pending as described on the next slide

Some of the Pending HMS-Specific Rules and Actions

- Pending Final Rules or Actions
 - Amendment 15 (spatial management)
 - eReporting
- Some of the Pending Proposed Rules or Actions
 - Atlantic blacknose and recreational shark fishery considerations
 - Swordfish, albacore tuna, and bluefin tuna quota adjustments
 - Swordfish and shark limited access permit considerations
 - Fishing gear considerations (buoy gear, speargun, bait nets)
 - Pelagic and demersal indicator species list considerations
 - Amendment 16 (shark fishery updates)
 - Amendment 17 (essential fish habitat updates)



HMS Management-Based Research Needs

- The most recent HMS Management-Based Research Needs and Priorities document was released in 2020
- An update to this document is being drafted to address emerging data needs, and to be responsive to changes in stock status, fishery priorities, regulations, and science
- A draft document is anticipated to be released for public comment later in 2025


Ecosystem Products and Services

Ecosystem-Based Fishery Management (EBFM)

- New EBFM Publication available (Fish and Fisheries, <u>Harvey et al. 2025</u>)
- New Climate Vulnerability Assessment available (PLoS Climate, <u>Loughran et al. 2025</u>)

Essential Fish Habitat (EFH)

- Phase 1 (<u>5-Year Review</u>) published 4/18/2024
- Phase 2 (Amendment 17) anticipated in Spring 2026
 - Help us develop our outreach products! Provide feedback on EFH mapper design.

HMS Catch Reporting Options

- HMS Angling, Charter/Headboat, and Atlantic Tunas General/Harpoon category permit holders can now submit catch reports for bluefin tuna, billfish, and swordfish via:
 - HMS Permit Shop website
 - HMS Catch Reporting smartphone app
 - SAFIS eTrips Mobile and Online available for HMS open access permit holders with GARFO or Southeast trip or logbook reporting requirements
 - Bluefin Data, LLC "VESL" available for HMS open access permit holders with Southeast for-hire logbook reporting requirements
 - No matter which option is used, HMS catch reports must be submitted within 24 hours of returning from a trip
- Currently, GARFO FishOnline does not collect all the data needed to satisfy HMS Catch Reporting requirements, but HMS is actively working with GARFO to add them
 - Platform users will need to continue submitting separate HMS catch reports via the HMS Catch Reporting app or Permit Shop website until further notice, or switch to SAFIS eTrips to submit their GARFO eVTRs
- For now, HMS Commercial Logbook participants must continue to submit paper logbooks



HMS Catch Reporting Options - Catch Cards

- North Carolina discontinued its HMS Catch Card program effective April 1, 2025
- Maryland is continuing their HMS Catch Card program through December 31, 2025
- Following discontinuation of a catch card program, federal HMS catch reporting requirements will apply to HMS permit holders using the options outlined in the previous slide
- For-hire captains with federal logbook requirements will have One-Stop Reporting options:
 - If they have South Atlantic logbook requirements, then either SAFIS eTrips or VESL would currently be their best reporting options
 - Those with GARFO eVTR reporting requirements will have to use SAFIS eTrips
- Billfish and swordfish tournament catch information will be collected and reported by registered HMS tournament operators
- NC sent a letter to all permit holders in early March outlining their federal reporting options, and the HMS Management Division followed up with emails with links to online resources
- A similar outreach campaign will be conducted for Maryland

Seafood Import Prohibitions under the Marine Mammal Protection Act (MMPA) Import Provisions

- On August 29, 2025, NOAA Fisheries announced its 2025 comparability finding determinations for foreign fisheries under the <u>MMPA Import Provisions</u>
- Any fish or fish products sourced from foreign fisheries that do not have comparable standards for reducing marine mammal bycatch as U.S. fisheries will be ineligible for import into the United States beginning on January 1, 2026
- Findings:
 - Full comparability for all fisheries from 89 nations
 - Partial comparability findings for 34 nations' fisheries
 - Denied comparability findings for all fisheries from 12 nations

NOAA's National Seafood Strategy

- The National Seafood Strategy outlines NOAA Fisheries' direction for supporting a thriving domestic U.S. seafood economy and enhancing the resilience of the seafood sector; supports EOs 14192 (Deregulation) and 14726 (Seafood Competitiveness)
- The vision is to ensure that:
 - U.S. seafood continues to be produced sustainably
 - The U.S. seafood sector contributes to the nation's climate-ready food production and to meeting critical domestic nutritional needs
 - U.S. seafood production increases to support jobs, the economy, and the competitiveness of the U.S. seafood sector
 - Supply chains and infrastructure are modernized with more value-added activity in the United States
 - Opportunities are expanded to grow the size and capacity of the seafood workforce
- We are working with the National Seafood Strategy Coordinator on a National HMS Pilot initiative in the coming months describing the current state of U.S. highly migratory species markets

HMS Recreational Data Updates – Large Pelagics Survey (LPS)

- NOAA Fisheries' Office of Science and Technology (OST) experienced staffing reductions and is shifting some staff to support the LPS part-time
- OST focusing on timeliness of LPS catch estimates; finalization of the LPS redesign will be delayed
- Regarding the LPS Redesign:
 - New Marine Recreational Information Program (MRIP) design submitted for certification in September 2024; peer-review workshop conducted in January 2025
 - Peer reviewer comments were positive; OST replies and requested analyses anticipated this fall
 - Calibration of a new LPS time series delayed until 2026
 - Timing of field implementation of new design is TBD
