FROM: Tom Nies, Executive Director SUBJECT: 2022 Management Priorities

- 1. The September Council meeting will include our first discussion of Council priorities for 2022. The goal of this first step is to identify the possible tasks. The actual selection of priorities will occur at the December meeting.
