**SUBJECT:** Purpose for Scallop AP meeting on May 22, 2019

There is a Scallop AP meeting at the Hilton in Providence, RI on Wednesday, May 22, 2019 at 9:00 AM. The Scallop Committee will convene on Thursday, May 23, 2019 at that same location. <u>Paper copies will not be mailed to you before the meeting.</u> Documents for this meeting will be e-mailed to you as they become available.

**Purpose:** The main goals of the Advisory Panel meeting are to:

- 1) Provide input on potential harvest of small scallops in the NLS-S-deep
- 2) Review Amendment 21 scoping comments and recommend next steps to the Committee
- 3) Develop recommendations on 2020/2021 Scallop RSA research priorities
- 4) Provide input on approaches to mitigate impacts on yellowtail flounder
- 5) Other Business

# Start of 2019 FY & 2020/2021 Scallop Specifications – Nantucket Lightship

**Recent Activity:** As part of the annual allocation cycle, the Council has closely tracked billions of small, slow-growing scallops in the deep water of the Nantucket Lightship South area. Through support of the Scallop RSA, researchers from the Virginia Institute of Marine Science (VIMS) gathered growth and condition data on animals in the NLS-S in July 2018, October 2018, January 2019, and May 2019. The AP will review preliminary findings of the on-going VIMS survey work in the NLS-S at the May 21st, 2019 meeting (i.e. AP/PDT meeting, RSA share day).

### **Next Steps/Anticipated Outcomes:**

- Provide feedback on how the fishing year is progressing, with focus on how fishing has been in the NLS-West.
- The AP will have an opportunity to provide feedback to the Committee on potential approach for managing the small, slow growing scallops in the NLS-S-deep.
- The AP may wish to develop a motion or consensus statement that signals support (or lack of support) to the Committee for developing a management approach to utilize these scallops. This could be support (or lack of support) for incorporating the NLS-S-deep scallops in specifications for FY2020.

### Amendment 21 to the Scallop FMP

**Recent Activity:** The Council conducted 10 scoping meetings to gather input for Amendment 21 to the Atlantic Sea Scallop FMP to address three specific issues: 1) measures related to the Northern Gulf of Maine (NGOM) Management Area, 2) Limited Access General Category (LAGC) individual fishing quota (IFQ) possession limits, and 3) ability of Limited Access vessels with LAGC IFQ to transfer quota to LAGC IFQ-only vessels. The Council heard oral comments at all 10 scoping meetings and received written comments.

**Next Steps:** Council staff will summarize information gathered through the Amendment 21 scoping process. The AP and Committee will have the opportunity review the document at their meetings. The Council is expected to consider scoping comments document at its June meeting in South Portland, ME. To keep Amendment 21 moving forward, the Council will likely identify goals and objectives for each element of the action (1, 2, 3 listed above), and recommend the development of alternatives to support/achieve the goals/objectives. As part of this process, the AP and Committee may wish to consider the vision statements developed as part of Amendment 11. If the Committee and Council do not identify goals and objectives or task the PDT with developing alternatives at this meeting, the timeline presented in the Amendment 21 action plan would likely be extended. While some progress on Amendment 21 should be expected this fall, the Council will also be developing specifications which can be very time consuming.

### **Anticipated Outcomes from this Meeting:**

Please Review A21 Draft Scoping Summary and be ready to address the following issues.

- 1. Is the Council's vision for the LAGC component different now than it was in Amendment 11? Part of the vision statement from Amendment 11, which transitioned the General Category component to a limited access fishery and IFQs was:
  - a. "a fleet made up of relatively small vessels, with possession limits to maintain the historical character of this fleet and provide opportunities to various participants including vessels from smaller coastal communities."
- 2. The AP and Committee should consider developing goals and objectives for the issues being addressed in Amendment 21. These can be used to help guide the development of alternatives. The preliminary rationale for action that is described in the Amendment 21 scoping document (i.e. which was approved at the January 2019 Council meeting), included:
  - a. Northern Gulf of Maine:
    - i. Support a [growing] directed scallop fishery in federal waters in the NGOM.
    - ii. Prevent unrestrained removals from the NGOM management area.
    - iii. Allow for orderly access to the scallop resource in this area by the LAGC and LA components.
    - iv. Establish mechanisms to set allowable catches and accurately monitor catch and bycatch.
  - b. Increase LAGC IFQ possession limits & allow the one-way transfer of quota from LA vessels with IFQ to LAGC IFQ-only vessels:
    - i. Improve overall economic performance of the LAGC IFQ component.
    - ii. Help ensure that the LAGC IFQ component remains profitable (promote profitability in the LAGC IFQ component of the fishery)
    - iii. Continued participation in the General Category fishery at varying levels.
- 3. Recommend that the Council recommend the development of alternatives designed to address the issues being considered in Amendment 21. The AP and Committee may wish to consider using the themes identified in the summary of scoping document.

### 2020/2021 Scallop RSA Research Recommendations

**Recent Activity:** The Scallop PDT developed input on research recommendations for the 2020/2021 Scallop RSA program over two meetings (April 4, 2019 & May 9, 2019), and through correspondence. The 2019/2020 Scallop RSA awards were announced on May 7, 2019.

**Next Steps:** Council staff will present information on the RSA program, recent awards, and input from the PDT and Scallop RSA Share Day.

**Anticipated Outcomes.** The AP may wish to recommend scallop RSA research priorities for 2020/2021 at this meeting. The Council will make final recommendations for the 2020/2021 cycle during the Scallop Report at the June Council meeting in South Portland, ME.

### **Action to Mitigate Impacts on Yellowtail Flounder**

**Recent Activity:** The Council has recommended that the Scallop Committee work on an action to mitigate impacts on yellowtail flounder. In January, the Committee tasked the Scallop PDT with analyzing the options for reducing bycatch of Georges Bank yellowtail flounder, including seasonal closures and reduced hanging ratio requirements. The PDT reviewed analyses that was prepared in FW29 during the development of flatfish AMs. The PDT supported forwarding time/area closure analyses to the Scallop AP and Committee for consideration in an upcoming action.

**Next Steps:** Council staff will summarize the PDT's recommendation from its April 4<sup>th</sup>, 2019 meeting. The PDT has invited researchers from the Coonamessett Farm Foundation to their July 23, 2019 meeting to present findings from a recent Scallop RSA project that investigated the utility of a dredge modifications for reducing flatfish bycatch.

## **Anticipated Outcomes:**

• The AP and Committee may wish to task the PDT with developing time/area closure alternatives in an upcoming action. The FW29 option was a closure of CAII and CAII ext from Nov. 16 – Dec. 31.

### Update from NOAA on Shell Stock Compliance Guide and Vessel Replacement Policy

**Recent Activity:** On April 30, 2019, GARFO released a compliance guide for landing and possessing inshell scallops. NOAA has developed a handout that describes scallop possession limits under the Atlantic Sea Scallop Fishery Management Plan to help captains and dealers when possessing and landing in-shell scallops (shell stock). This includes meat weight and in-shell limits and examples of how to measure what vessels have onboard and at time of landing. On April 15, 2019 the Council received correspondence from NOAA explaining its vessel replacement policy.

**Next Steps:** GARFO staff will present and field questions on both topics at your meeting.
