SUBJECT: Purpose for Scallop AP and Committee meetings on October 26 & 27, 2021

In light of the COVID-19 pandemic, the Council will be holding the joint Scallop Advisory Panel and Committee meetings by webinar on October 26 (AP) and October 27, 2021 (Committee). Documents for this meeting will be posted to a Sharefile site and then the Council's website as they become available. You will receive a link to access files ahead of the meeting.

**Purpose:** The main objectives of the meetings are to:

- 1) Review analyses and recommend specification alternatives to be developed in Framework 34. *Note: The AP and Committee are not selecting preferred alternatives at this meeting* the discussion is about what alternatives will be included in the framework.
- 2) Receive updates on the Evaluation of Rotational Management project.
- 3) Recommend 2022 scallop work priorities.
- 4) Discuss other business.

- b. **Seconding Motions:** AP and Committee: You can raise your hand in the webinar to second the motion. Council staff will confirm this by voice over the webinar so it is clear who the maker and seconder of each motion are.
- c. **Discussion on each Motion:** The AP and Committee will have an opportunity to discuss each motion, followed by an opportunity for the public to comment. Please raise your hand on the webinar if you would like to speak to a motion. The Chair will call on individuals who would like to address the motion. After the AP/Committee have a chance to discuss this motion, the Chair will call on members of the public.
- d. **Voting:** When the Chair is ready to call the vote, Council staff will do a roll call vote. Staff will provide the vote count, which will be confirmed by the Committee chair. At the discretion of the Chair, motions can also be approved by unanimous consent in lieu of a roll call vote.

#### Framework 34: Survey Results and Projections

**Recent Activity:** The Scallop PDT has met several times to discuss survey results and develop projections for 2022 and 2023 (default). The SSC met on October 13, 2021 and recommended OFL and ABC values for the next two fishing years. The PDT has been working to complete Committee tasking from the September 22, 2021 meeting. The PDT plans to present the results of the following runs at your meeting next week, along with open area DAS calculated at F=0.36, and 24 DAS. Projections for the Stellwagen area of the NGOM will also be available at your upcoming meeting.

## Anticipated Outcomes: Develop recommendations for measures to include in FW34

- 1. Motions for alternatives to be included in FW34 that identify:
  - o Full time limited access area trip limits
  - o Access area allocations for 2022 (number of trips in each area)
  - o Target open area F rate, full time LA DAS
- 2. Provide recommendations on possible new closures (ex: NYB and yield closures).
- 3. Provide recommendations for possible 2023 (default) measures specifically whether an access area trip should be allocated as part of default measures.
- 4. Provide recommendations on part-time limited access allocations.
- 5. Provide recommendations on the distribution of LAGC IFQ access area trips for FY 2022.
- 6. Provide recommendations on default measures for the NGOM for FY2023.
- 7. Provide input on where Scallop RSA compensation fishing can occur.
- 8. Provide input on any measures to reduce fishery impacts(e.g., the timing of seasonal closure on eastern GB).

# **Evaluation of Rotational Management**

**Recent Activity.** The Scallop PDT, with the assistance of Dr. Cate O'Keefe of Fishery Applications Consulting, have been assembling information to address the goals and objectives of this project.

**Next Steps.** Dr. Cate O'Keefe will present an overview of project progress at your October meetings. The PDT will deliver a draft report to the Council in December. A final report is expected to be delivered to the Council for the February 2022 Council meeting.

#### **Anticipated Outcomes:**

1. Provide feedback, and consider making recommendations for next steps (if necessary).

## **2022 Scallop Work Priorities**

**Recent Activity.** The Scallop AP and Committee reviewed preliminary lists at their meetings in September. The Council identified a list of potential work priorities for 2021 at its September meeting.

**Next Steps.** Staff will review progress toward 2021 work priorities, and the list of potential 2022 priorities. The Council will set 2022 work priorities at the December meeting.

# **Anticipated Outcomes:**

1. Develop recommendations for 2022 work priorities. Identify priorities that the AP and Committee would like to see the Council work on in 2022. Ranking is not required.
