Overview on GB Flatfish AMs and GB Yellowtail Background Information

Scallop Fishery's GB YT AM:

Who:

• The accountability measure applies to the Limited Access and Limited Access General Category components of the fishery.

What:




Figure 1 - Georges Bank yellowtail accountability measure area, shown in RED.

• The scallop fishery is subject to a gear restricted area (GRA) on eastern Georges Bank if the accountability measure is triggered (Figure 1). Required gear: 5 row apron and 1.5:1 hanging ratio.

Where:

• The closure covers the Closed Area II Access Area and Closed Area II Extension Area (Figure 1).

When:

- The duration of the AM closure depends on the amount (percentage) of the sub-ACL overage. The penalty schedule is used to determine if a "small" (Nov. 15 Dec 31) or a "large" (year-round) AM is triggered.
- Overages in year 1 (Y1) can trigger accountability measures in either the following year (Y2) or two fishing years after the overage (Y3), depending on when the overage is known. The GB YT AM cannot be implemented in-season.
 - Because final year end catch data is often not available until after the start of the scallop fishing year (April 1 in FY2019), AMs triggered by overages in Y1 are not implemented until Y3.
 - NMFS evaluates scallop fishery catch of GB YT in-season (i.e. on or around January 15th of each fishing year). If estimated catch at this point in the year indicates that the scallop fishery has exceeded its sub-ACL by more than 50%, an AM could be put in place for Y2.

Why (AM triggers – see Table 2):

- There are two (2) ways to trigger the GB YT scallop AMs. Either:
 - The scallop fishery exceeds its sub-ACL and the US ACL is exceeded.
 - o The scallop fishery exceeds its sub-ACL by more than 50% (150% of sub-ACL).

<u>NOTE: The Northern Windowpane Flounder AM for the scallop fishery uses the same GRA,</u> area, and triggers. The rationale for this was that there would be secondary benefits for other stocks in poor condition if one of the AMs was triggered.

Scallop Resource Outlook for FY2019:

Georges Bank Yellowtail Allocations:

- US TMGC negotiated a GB YT TAC of 140 mt.
- The US fishery receives 76% of the negotiated quota (140 mt).
 - U.S. TAC = 106 mt
- Scallop fishery sub-ACL is 16% of the US ABC.
- The scallop sub-ACL for FY2019 would be \sim 17 mt.

Scallop Fishery Access on Georges Bank:

- GB YT bycatch estimate for the preferred alternative in FW30: 12.14 mt
- Bycatch estimate if there was one 15,000 lb FT LA AA trip to CAII: 10.42 mt.

• NOTE: The bycatch estimate for N. windowpane under this scenario is 63.05 mt (FY2019 N windowpane sub-ACL = 18 mt).

Outlook for FY 2020:

- The PDT anticipates at least 6 million lbs of rotational scallop harvest could come from the southeast part of Eastern Georges Bank (i.e. Closed Area II Access Area) in FY 2020 based on 2018 surveys.
 - Bycatch estimates of GB YT generally spike in years when an access area trip is allocated. In general, rotational management in this area leads to a see-saw effect on bycatch estimates.
- The Council may want to consider the impact of N. windowpane bycatch when Closed Area II re-opens. Projections of 2019 access area fishing in CAII suggested that the scallop fishery could exceed this sub-ACL by 150%.
