Notes:

- The work items outlined in Table 1 are not in rank order. However, specifications and the development of an accountability measure for northern windowpane are regulatory requirements and will need to be developed for the start of FY 2018.
- *NEW (post April Council meeting)*: The Council voted in April to remove gear modifications to protect small scallops from the 2017 priority list. Staff anticipate that 2017 priorities will be addressed in a single framework action (FW29) in 2017.
- Completion of the LAGC IFQ five year review is a holdover from the 2016 process, and will be a top priority for Council staff this spring.
- The programmatic RSA review has been discussed at the Council's Executive Committee, and is likely to be a joint effort between the Council, NEFSC, and GARFO.
- Assessment updates are planned for all groundfish stocks this year. This will update the sub-ACLs for the four allocated stocks, and add to the scallop PDT workload in the fall with respect to projections for several flatfish stocks.
