## **Tuesday, June 12, 2018**

## **SKATE COMMITTEE**

1. Dr. McKenzie moved on behalf of the Committee: that the Council recommend that all possession limit alternatives (Sections 4.2, 4.3 and 4.4) be moved to considered but rejected.

The motion *carried* unanimously on a show of hands (16/0/0).

2. Dr. McKenzie moved and Mr. Pappalardo seconded: that the Council submit Framework adjustment 6 to the Northeast Skate Complex FMP to GARFO.

The motion *carried* on a show of hands (15/0/1).

## **OBSERVER COMMITTEE**

The Council agreed by consensus to send the Draft comment letter regarding NMFS draft policy directive for allocating costs in EM programs for federally managed U.S. fisheries.

## **HERRING COMMITTEE**

## RH/S stocks in the fishery

3. Mr. Kendall moved on behalf of the Committee: That the Council recommend no action in Section 4.1 of the draft river herring/shad white paper (maintain current management approach).

The motion *carried* on a show of hands (15/1/1).

## MAFMC Mackerel Action

By consensus, the Herring Committee recommends the Council draft a letter to the Mid-Atlantic Council supporting the in-season alternatives to manage mackerel landings that are under development in the mackerel rebuilding framework for FY2019-2021.

The Council agreed by consensus with this recommendation.

## 2019-2021 Herring Specifications

4. Mr. Keliher moved and Mr. Stockwell seconded:

that upon the approval of the 2018 Atlantic Herring Stock Assessment peer review, or sooner if possible, the Regional Administrator, under existing authority allowing for inseason adjustments, take action to cap the 2018 harvest of Atlantic herring at the 2017 catch levels by management areas 1A, 1B and 3. The Area 2 sub-ACL should be set so that current 2018 Area 2 landings equal 92 percent of the Area 2 sub ACL.

### 4a. Friendly amendment:

that upon the approval of the 2018 Atlantic Herring Stock Assessment peer review, or sooner if possible, the Regional Administrator, under existing authority allowing for inseason adjustments, take action to cap the 2018 harvest of Atlantic herring at the 2017 catch levels by management areas 1A, 1B and 3. The Area 2 sub-ACL should be set to 8200 mt for 2018 sub ACL.

The motion *carried* on a show of hands (16/0/1).

5. Mr. Kendall moved on behalf of the Committee: that the Council initiate herring specification action for FY 2019-2021.

Mr. Stockwell moved on behalf of the Committee: that the Council delay selection of the final range of alternatives for Amendment 23 until to no sooner than the September 2018 Council meeting in order to allow for the alternatives to be aligned with completed Plan Development Team analyses and final report with recommendations offered by the Fishery Data for Stock Assessment Working Group.

The motion *carried* unanimously on a show of hands (17/0/0).

4. Mr. Grout moved and Mr. Balzano seconded: that the Council task the Plan Development Team to analyze groundfish fishing activity and groundfish landings of small vessels (e.g. <50 ft.) to see if it would be appropriate to exempt vessels from at-sea monitoring and dockside monitoring or have lower levels of at-sea and dockside monitoring than larger vessels (e.g.>50 ft.) while addressing the purpose and need of the amendment.

The motion *failed* on a show of hands (3/13/1).

## Fishing Year 2019 Recreational Management Measures

5. Mr. Stockwell moved on behalf of the Committee:
That in the consultation process for Georges Bank cod recreational measures, the Council requests that the Greater Atlantic Regional Fisheries Office review different methodologies for determining the recreational management measures for fishing year 2019.

The motion *carried* on a show of hands (15/0/1).

#### **NAFO** Discussion

6. Mr. Terry Alexander moved and Ms. Etrie seconded: that the Council write a letter to have the agency/DOC to appoint NAFO commissioners as soon as possible to formulate the positions in advance of the September 2018 Meeting.

## **SCALLOP COMMITTEE**

### Monitoring and Catch Accounting

- 7. Mr. Balzano moved on behalf of the Committee: that the Council develop measures to expand the VMS pre-landing notification requirement to cover Limited Access open area trips.
- 7a. Mr. Balzano moved to substitute and Mr. Terry Alexander seconded:
  That the Council requests that GARFO use their authority to require a VMS pre-landing notification on all Limited Access scallop trips.

  offshore wind and oil and gas development with the exception of the second policy goal
  for offshore oil. (Renewable energy, if implemented in a manner which minimizes
  impacts on fish habitat and fisheries, may be more consistent with the Council's vision for
  sustainable fisheries).
