Tuesday, December 2, 2025

Whiting Committee Report

1. Ms. Odell moved and Mr. Platz seconded: to approve the Whiting Plan Development Team's (PDT) recommendation to defer application of the red hake post-season accountability measure that would otherwise be applied to the TAL trigger and possession limits in fishing year 2026. A letter should be sent to GARFO following this request.

The motion *carried* with one abstention, Mr. Pentony.

Spiny Dogfish Report

Framework Adjustment

Specifications for 2026-2027

2. Ms. Griffin moved and Mr. Pappalardo seconded: to select as the preferred alternative in Alternative Set 6 – Considers 2026-2027 Specifications: Alternative 6C Re-suspend the Council's risk policy and set 2026 and 2027 ABCs = 2025 OFL (projected and implemented) but use the assessment ratio approach for discard set-asides. This is consistent with the Mid-Atlantic Fishery Management Council's recommendations.

The motion *carried* on a show of hands (17/0/0).

Accountability Measures

3. Ms. Griffin moved on behalf of the Committee: to select as the preferred alternative in Alternative Set 1 – Considers whether ACL paybacks should depend on biomass level: Alternative 1B Middle cautionary modified payback scaling. This is consistent with the Mid-Atlantic Fishery Management Council's recommendation.

The motion *carried* on a show of hands with one abstention, Mr. Pentony (14/2/1).

4. Ms. Griffin moved on behalf of the Committee: to select as the preferred alternative in Alternative Set 3 – Considers whether relaxation of ACL paybacks should depend on if stock is in a rebuilding plan or not: Alternative 3A Always pay back ACL overages fully if stock is in a rebuilding plan. This is consistent with the Mid-Atlantic Fishery Management Council's recommendation.

The motion *carried* on a show of hands (17/0/0).

5. Ms. Griffin moved on behalf of the Committee: to select as the preferred alternative in Alternative Set 4 – Considers whether ACL paybacks should depend on one year or an average of years: Alternative 4B Calculate paybacks based on average ACLs and average catches, and if paybacks are scaled based on biomass, use the most recent projected biomass. This is consistent with the Mid-Atlantic Fishery Management Council's recommendation.

The motion *carried* on a show of hands with one abstention, Mr. Pentony (16/0/1).

6. Ms. Griffin moved on behalf of the Committee:

to select as the preferred alternative in Alternative Set 5 – Considers whether specifications should be modified to allow for a closure buffer of federal waters (the EEZ) at up to 105% of the landings quota: Alternative 5A Clarify that specifications can set closures of federal waters (the EEZ) at up to 105% of the landings quota when biomass is projected to be greater than 50% of the biomass target in the relevant fishing year AND SET to 105% for 2026-2027 specifications. This is consistent with the Mid-Atlantic Fishery Management Council's recommendation.

The motion *failed* on a show of hands (1/16/0).

7. Ms. Griffin moved and Mr. Pentony seconded: to adopt no action in Alternative Set 5.

The motion *carried* on a show of hands (17/0/0).

8. Ms. Griffin moved on behalf of the Committee:

to select as the preferred alternative in Alternative Set 2 – Considers whether ACL paybacks should depend on the source (catch type) of the overage: No Action/Status Quo. This is consistent with the Mid-Atlantic Fishery Management Council's recommendation.

The motion *carried* on a show of hands (17/0/0).

9. Ms. Griffin moved and Mr. Alexander seconded: to submit the Spiny Dogfish Framework to NOAA Fisheries.

The motion *carried* with one abstention, Mr. Pentony.

Scallop Committee Report

Framework 40

Action 1: Overfishing Limit and Acceptable Biological Catch

1. Ms. Griffin moved on behalf of the Committee: that the Council adopt in Section 4.1, Alternative 4.1.2, Updated OFL (Overfishing Limit) and ABC (Acceptable Biological Catch) for FY 2026 and FY 2027, as the preferred alternative.

Action 2: Northern Gulf of Maine Management and Total Allowable Landings (TAL) Setting

- 2. Ms. Griffin moved on behalf of the Committee:
 - that the Council adopt in Section 4.2.1, Alternative 3, Set the NGOM (Northern Gulf of Maine) TAL, with set-asides to support research, monitoring, and a directed LAGC fishery. Set NGOM TAL at F=0.18 using Stellwagen, Ipswich, Jeffreys, Platts, and Machias Seal Island, as the preferred alternative.
 - FY 2026 NGOM TAL would be set at 417,642 lb.
 - FY 2026 NGOM Set-Aside would be set at 372,756 lb.
 - FY 2027 NGOM Set-Aside would be set at 186,378 lb.
- 2a. Mr. Pappalardo moved to amend and Mr. Hansen seconded:

that the Council add and adopt in Section 4.2.1, Alternative 4, Set the NGOM (Northern Gulf of Maine) TAL, with set-asides to support research, monitoring, and a directed LAGC fishery. Set NGOM TAL at F=0.21 using Stellwagen, Ipswich, Jeffreys, Platts, and Machias Seal Island, as the preferred alternative.

• FY 2026 NGOM TAL would be set at 482,753lb.

 - Closure of Area II (Closed Area II South and Extension) and Nantucket Lightship (South and North).
 - 60-day carryover period for FY 2025 access area trips to Area I would begin on April 1. Area I would not have a delayed opening from April 1, 2026 May 15, 2026.
- 3a. Mr. Hansen moved to amend and Mr. Platz seconded: that the Council adopt in Section 4.3, Alternative 3, 36 Days-at-Sea, as the preferred alternative:

- 36 Days-at-Sea for full-time Limited Access permit holders (Open area F=0.36) and 14.4 Days-at-Sea to part-time Limited Access permit holders
- Closure of Area II (Closed Area II South and Extension) and Nantucket Lightship (South and North).
- 60-day carryover period for FY 2025 access area trips to Area I would begin on April 1. Area I would not have a delayed opening from April 1, 2026 May 15, 2026.

Transboundary Management Guidance Committee

- 6. Mr. Pappalardo moved and Mr. Alexander seconded: that the Council approve the Transboundary Management Guidance Committee's recommendations for United States/Canada total allowable catches (TACs) for 2026 as:
 - Eastern Georges Bank cod at a TAC of 473 mt.
 - Eastern Georges Bank haddock at a TAC of 4,750 mt, and

• Georges Bank yellowtail flounder at a TAC of 57 mt.

The motion *carried* on a show of hands (17/0/0).

Action 1 – Status Determination Criteria

- Fishing year (FY) 2026 specifications for Georges Bank (GB) cod, GB haddock, and GB yellowtail flounder,
- FY2026-FY2030 specifications for Cape Cod/Gulf of Maine (CC/GOM) yellowtail flounder (as recommended by the Committee to set constant ABCs), Southern New England/Mid-Atlantic (SNE/MA) yellowtail flounder, GB winter flounder, GOM winter flounder, SNE/MA winter flounder, redfish, ocean pout, and Atlantic wolffish (refer to Table 12 in the draft Framework 72 discussion document).

 - 1) Preliminarily, approve white hake OFLs/ABCs for FY2026-2030 as recommended by the SSC
 - 2) Request the SSC consider FY2026-2030 ABCs for white hake based on 75% Fmsy, taking into consideration the Council's Risk Policy and rebuilding plan. The Council accepts any revised SSC recommendations without discussion for adoption in Framework 72.
