## SMALL-MESH MULTISPECIES (WHITING) COMMITTEE REPORT

1. Mr. Bellavance moved on behalf of the Committee: that the Council consider southern whiting possession limit changes in the specifications package based on mesh size.

## Framework Adjustment 61 / Specifications and Management Measures

5. Mr. Alexander moved on behalf of the Committee: that under Action 1 (4.1 - Status Determination Criteria), the Council selects as preferred 4.1.2 Alternative 2 – Updated Status Determination Criteria.

that under Action 2 (4.2 – Formal Rebuilding Program), the Council selects as preferred 4.2.2 Alternative 2 - Revised Rebuilding Strategy for White Hake, Option B ( $T_{target}$  of 10 years, rebuilding by 2031, at  $F_{rebuild}$  of 70%  $F_{MSY}$ = 0.117, which results in a 87.4% probability of achieving  $B_{MSY}$ ).

that the Council write a letter to the MAFMC expressing concern over recent catches of southern windowpane flounder in the squid fishery and the potential impacts this catch may have on future triggers of AMs that would impact the groundfish, scallop and other large mesh fisheries (e.g. fluke) in light of recent reductions in the southern windowpane flounder ACL.
