GROUNDFISH COMMITTEE REPORT

Framework Adjustment 61/Specifications and Management Measures

4.4 Action 4 – Commercial Fishery Measures for Sectors

- 1. Mr. Alexander moved on behalf of the Committee:
 - 1. that the Council adopt the following clarification: annual and monthly thresholds are intended to provide more defined performance standards, accountability, and transparency to achieve the goals and objectives of 4.4.2 Alternative 2 Universal Sector Exemption for Redfish.
 - 2. that the Council include in 4.4.2 Alternative 2 Universal Sector Exemption for Redfish: The purpose is to establish a universal exemption, rather than an annual exemption, to increase stability and certainty for current and potential participants and improve Council control and oversight of the fishery.

The goal of the redfish universal sector exemption is to achieve optimum yield of the redfish resource.

Objectives include:

- 1. Allow use of an efficient mesh size codend to facilitate harvest of redfish.
- 2. Increase the harvest of redfish while reducing to the extent practicable bycatch of other groundfish stocks.
 - 3. Restore flexibility lost with 2020 contraction of the redfish exemption area.
 - 4. Remove areas from the exemption which provide little opportunity to effectively target redfish, or little ability to achieve exemption performance thresholds.
- 3. that the Council recommends that NMFS/GARFO be tasked with monitoring and enforcement of any thresholds and recommends this be clarified in the alternative. Sectors would be responsible for complying with the exemption (as with all sector provisions).
- 4. that the Council include in the alternative a review to occur the next time the redfish stock is assessed. The review could include evaluation of the monthly and annual thresholds performance, vessel-level performance, bycatch of other groundfish stocks, any observed changes in selectivity, as well as purpose, goals, and objectives but is not limited to these criteria. The Groundfish PDT would prepare a report to the Groundfish Committee.

Chairman's Report

The Council agreed by consensus to increase the SSC stipend to \$300 per day and remove from the Operations Handbook the definition that says eight members constitute a quorum for Scientific and Statistical Committee meetings.

SCALLOP COMMITTEE REPORT

Action 1: Overfishing Limit and Acceptable Biological Catch

1. Mr. Balzano moved on behalf of the Committee: that the Council select in Action 1 – Overfishing Limit and Acceptable Biological Catch, Alternative 2 (4.1.2), updated OFL and ABC for FY2021 and FY2022, as preferred.

Action 2 – Northern Gulf of Maine TAC Setting

2. Mr. Balzano moved on behalf of the Committee:

that the Council select in Action 2, Northern Gulf of Maine TAC setting, Alternative 2 (4.2.2), set the NGOM TAC, with first 70,000 lbs to LAGC, then 50/50 split between LA and LAGC, as the preferred alternative. Select as preferred:

- Option 2 in Section 4.2.2.1.2 Set NGOM TAC for 2021 at F=0.20, NGOM TAC of 175,000 pounds, LAGC share 122,500 pounds.
- •Sub-Option 1 in Section 4.2.2.2.1 Set the NGOM TAC for 2022 at F=0.20, NGOM of TAC 74,000 pounds, LAGC Share 72,000 pounds. The Stellwagen Bank closure in place for FY2021 would remain in place for FY2022.

The Council agreed by consensus.

Action 3 – Fishery Specifications

3. Mr. Balzano moved on behalf of the Committee:

that the Council select in Action 3, Alternative 5 Option 1 (4.3.5.1), Four Access Area Trips, with 1 trip to the Mid-Atlantic Access Area, and open areas fished at F=0.3 (24 DAS). This would allocate the following:

- 1 trip to Mid-Atlantic Access Area
- 1.5 trips to Nantucket Lightship South Access Area
- 1.5 trips to CAII-SW + CAII-Ext Access Area
- Full Time Limited Access trip limit of 18,000-lbs.

CAI would remain a rotational area designated for LAGC Access Area trips and RSA compensation fishing only. In addition to standard default measures, allocate 1 trip to the MAAA as a default measure for FY2022, with the MAAA opening on May 1, 2022.

Action 4 – Access Area Trip Allocations to the LAGC IFQ Component

4. Mr. Balzano moved on behalf of the Committee:

that the Council select in Action 4, Alternative 2 (4.4.2), Update LAGC IFQ Access Area Trip Allocations, Distribute Closed Area II Access Area Allocation to CAI Only, as preferred. The access area trip allocations for the LAGC IFQ for FY 2021 would be:

- 571 in the MAAA
- 856 in the NLS-S
- 856 in CAI

Action 5.1 – RSA Compensation Fishing

5. Mr. Balzano moved on behalf of the Committee:

that the Council select in Action 5.1, RSA compensation fishing, Alternative 2, allow RSA compensation fishing in open areas and the Mid-Atlantic Access Area, NLS-South, Closed

Area II (June 1 – August 15 only), and Closed Area I, with limited RSA compensation fishing in the NGOM Management Area, as preferred.

Action 5.2 - Seasonal Closure of Closed Area II Access Area to Reduce Impacts on Georges Bank Yellowtail Flounder and Northern Windowpane Flounder

that the Council select in Action 5.2 – Seasonal Closure of Closed Area II Access Area to Reduce Impacts on Georges Bank Yellowtail Flounder and Northern Windowpane Flounder, Alternative 2 (4.5.2.2), Extend the (Aug. 15 – Nov. 15) Seasonal Closure of Closed Area II Access Area through November 30th in FY 2021 and Include CAII-Ext in the Seasonal Closure, as preferred.
