MAGNUSON-STEVENS FISHERY CONSERVATION AND MANAGEMENT ACT (MSA)

1. Mr. Bellavance moved and Dr. Sissenwine seconded: that the Council approves the comment letter, as modified by the Executive Director based on today's discussion, to Congress on H.R. 4690, the Sustaining America's Fisheries for the Future Act legislation.

Framework 9

Sub-ACL overages less than 10% would not have a payback provision and clarify the alternative that if the overage is equal to or greater than 10%, the pound for pound payback would only be for catch more than 10%. If the total ACL is exceeded the pound for pound payback would be for the full overage amount and reduced from future sub-ACLs and the total ACL.

MONKFISH COMMITTEE REPORT

1. Ms. Etrie moved on behalf of the Committee: that the Council request that the Northeast Region Coordinating Council and NEFSC maintain their timeline and complete a 2022 monkfish stock assessment.

SKATE COMMITTEE REPORT

2. Ms. Etrie moved on behalf of the Committee: that the Council recommends Alternative 2 (37,236 mt) as the final preferred alternative for the Skate ABC for FY 2022-2023.

3. Ms. Etrie moved and Mr. Salerno seconded: that the Council submit the FY 2022-2023 Skate Specifications to NOAA Fisheries.

The Council agreed by consensus with one abstention (Mr. Pentony).

4. Ms. Etrie moved on behalf of the Committee:

that the Council initiate a framework adjustment action to consider the measures identified by the Skate Committee and discontinue work on Amendment 5. The framework would clarify the Skate FMP objectives as developed in Amendment 5 and include the alternatives developed through Amendment 5 on the federal skate permit (Section 4.2 of Amendment 5 discussion document).

WHITING COMMITTEE REPORT

5. Mr. Bellavance moved on behalf of the Committee: that based on the PDT and AP recommendations in the Annual Monitoring Report, the Council should advise the Regional Administrator to not make the automatic adjustment to the southern red hake TAL trigger because of 2020 catch overages. This would leave the 40.4% TAL trigger in place and allow for additional data collection for fishing year 2021.
