# Monday, September 23, 2019

# **ELECTION OF OFFICERS**

Mr. Stockwell moved and Mr. Kendall seconded:
Because Council members Dr. Michael Sissenwine and Eric Reid will be attending the
annual NAFO meeting at the same time as the September Council meeting, the Council will
allow them to vote in the election of officers (Chair, Vice-Chair, and Executive Committee)
via remote access. They will not be allowed to vote remotely on other issues before the
Council at this meeting.

## ATLANTIC HERRING COMMITTEE REPORT

- 2. Mr. Kendall moved on behalf of the Committee: that the Council initiate a framework action to protect spawning herring in herring management areas 3, 2, and 1B. The Council suggests the following range of alternatives be developed and analyzed, at a minimum:
  - Spawning closure area
    - -- Consensus spawning areas identified in fig. 3.3. of Herring Spawning Review paper around the Northern Flank of GB;
    - -- Consensus spawning areas identified in fig. 3.3. of Herring Spawning Review paper west of the Great South Channel;
    - -- A rectangular box around all sources of data along the northern edge of GB and around the GSC identified in Fig. 3.1 of the Herring Spawning Review paper.
  - Spawning closure durations during September and October
    - -- 4 weeks
    - -- 6 weeks
    - -- 8 weeks
  - Gear/Fisheries that would be restricted by these spawning measures

- -- All gear types fishing for herring
- -- All vessels possessing more than 2,000 pounds of herring
- 2b. Dr. Pierce moved to amend and Ms. Etrie seconded:

# TRANSBOUNDARY MANAGEMENT GUIDANCE COMMITTEE (TMGC)

1. Mr. Stockwell moved on behalf of the Committee: that the Council accept the Transboundary Management Guidance Committee (TMGC) recommendations for US/CA 2020 total allowable catches for Georges Bank yellowtail

flounder (162mt), Eastern Georges Bank cod (650mt), and Eastern Georges Bank haddock (30,000mt).

The motion *carried* unanimously on a show of hands (13/0/0).

# **GROUNDFISH COMMITTEE – PART ONE**

Framework Adjustment 59/Specifications and Management Measures

2. Mr. Stockwell moved and Ms. Etrie seconded: that the Council add Option 2: Revise the Georges Bank Cod Incidental Catch TAC to remove the allocation for the Closed Area I Hook Gear Haddock Special Access Program (SAP) under the draft options for Closed Area I Hook Gear Haddock SAP.

The motion *carried* unanimously on a show of hands (14/0/0).

- 3. Mr. Godfroy moved and Mr. Bellavance seconded: that the Council direct staff to continue working on and include alternatives in FW 59 to update GOM cod and GOM haddock commercial/recreational allocations raised by new Marine Recreational Information Program (MRIP) data.
- 3a. Ms. Etrie moved and Mr. Alexander seconded: to recommit the previous motion to the Groundfish Committee and Groundfish and Recreational Advisory Panels for discussion and consideration.

The motion *carried* on a show of hands (9/5/0).

#### GROUNDFISH COMMITTEE REPORT – PART TWO

#### Amendment 23/Groundfish Monitoring

4. Mr. Stockwell moved on behalf of the Committee: that the Council move Section 4.4.2 Option 2: Revised Management Uncertainty Buffers for Allocated Groundfish Stocks to Considered but Rejected.

The motion *carried* on a show of hands (11/3/0).

- 5. Mr. Alexander moved and Ms. Etrie seconded: to add a sub-Option to Section 4.2.2.1.2 for coverage levels based on trips of the vessel (e.g., if the coverage level is 25% of trips taken by the vessel, then the vessel takes four trips, it would get covered once). These would be vessel specific coverage rates.
- 5a. Mr. Alexander moved and Ms. Patterson seconded: to remand this motion back to the Groundfish Committee for further analysis.

The motion *carried* on a show of hands (10/3/1).

6. Mr. Pappalardo moved and Mr. Bellavance seconded: to remove 4.1.2.1.3 Option 3: Dockside Monitoring as an Optional Program for Sectors.

The motion *carried* on a show of hands (13/0/1).

# HABITAT COMMITTEE REPORT

Developing policies on non-fishing impacts on EFH

#### Committee recommendations:

- Develop two new policies related to the habitat impacts associated with aquaculture and submarine cables
- Consider whether the offshore wind energy policy should be updated given the potential for floating wind farms
- Convene a work team or teams to begin scoping these issues and developing expertise, drawing from PDT, AP, Committee membership
